BACKGROUND INFORMATION:

Mayor Ron Nirenberg formed the Planning Commission Subcommittee to address the unprecedented high number of Planning Commission applications received by the Office of the City Clerk. He asked the City Clerk to staff the Subcommittee and facilitate the selection process. The Subcommittee terminated upon submission of the nine (9) applications selected and forwarded to the Governance Committee.

Each Governance Committee member was permitted (but not required) to add one applicant to the selected slate. There are currently four (4) slots available with terms of office to expire October 6, 2019. Two (2) applicants are seeking reappointment and were selected by the Planning Commission Subcommittee for interviews.

Board Appointments require full City Council approval.

RECOMMENDATION:

The City Clerk recommends approval of the Governance Council Committee's selection and that same be submitted for the City Council Meeting on March 8, 2018.

The Commission advises the City Council on the Master Plan for the physical development of San Antonio. The Commission also provides recommendations on capital improvements, and administers regulations on subdivisions and platting, to include the Extra-Territorial Jurisdiction.

Meetings are held twice a month on the second and fourth Wednesdays at 2:00 PM at the Cliff Morton Development and Business Services Center, 1901 South Alamo, 1st Floor. 
