AN ORDINANCE 2018-02-15-0117

AMENDING THE LAND USE PLAN CONTAINED IN THE MIDTOWN NEIGHBORHOODS PLAN, A COMPONENT OF THE COMPREHENSIVE MASTER PLAN OF THE CITY, BY CHANGING THE USE OF APPROXIMATELY 0.1722 ACRES OF LAND LOCATED AT 115 CINCINNATI AVENUE, LEGALLY DESCRIBED AS LOT 28, BLOCK 3, NCB 3032 AND 0.0032 ACRES OUT OF LOT 31, BLOCK 3, NCB 3032 FROM "MEDIUM DENSITY RESIDENTIAL" TO "MIXED USE."

WHEREAS, the Midtown Neighborhoods Plan was adopted on November 9, 2005 by City Council as a component of the City's Comprehensive Master Plan adopted May 29, 1997; and

WHEREAS, the Unified Development Code requires consistency between zoning and the Comprehensive Master Plan and Section 213.003 of the TEXAS LOCAL GOVERNMENT CODE allows amendment of the Comprehensive Master Plan following a public hearing and review by the Planning Commission; and

WHEREAS, a public hearing was held on September 27, 2017 by the Planning Commission allowing all interested citizens to be heard; and

WHEREAS, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Midtown Neighborhoods Plan, a component of the Comprehensive Master Plan of the City, is hereby amended by changing the use of approximately 0.1722 acres of land located at 115 Cincinnati Avenue, legally described as Lot 28, Block 3, NCB 3032 and 0.0032 acres out of Lot 31, Block 3, NCB 3032, from "Medium Density Residential" to "Mixed Use". All portions of land mentioned are depicted in **Attachment "I"** attached hereto and incorporated herein for all purposes.

SECTION 2. This ordinance shall take effect February 25, 2018.


