## **BACKGROUND INFORMATION:**

VIA manages and operates the Metropolitan Transit Authority within Bexar County, Texas. VIA is governed by a Board of Trustees with eleven appointees, five (5) of which are appointed by the San Antonio City Council. Board members are appointed to staggered two-year terms and may serve up to four terms. There are currently four (4) slots available for members whose terms have expired. One (1) slot is vacant due to the resignation of Carl A. Morgan.

Three (3) slots are for the remainder of unexpired terms of office to expire December 31, 2018. Two (2) slots are for the remainder of unexpired terms of office to expire December 31, 2019.

North-Central Corridor Light Rail Feasibility Analysis - Mr. Rodriguez served as Project Manager for this effort, which was solely intended to understand the challenges and opportunities associated with building a Light Rail Transit connection specifically between San Antonio International Airport and downtown San Antonio, primarily along San Pedro Ave. The study looked at three primary alternatives for making the rail connection by traveling through a higher density, established if not historic part of the city, up to a much wider arterial right-of-way with surplus capacity that could be used for dedicated transit infrastructure. These considerations included re-appropriation of narrower City streets primarily for transit use, construction of a separate, but parallel route along the Union Pacific Austin Mainline 1 Subdivision, and the construction of a fully grade-separated and parallel tunnel. The study also included a review of the latest guidance and research on the topic of ground transportation services to Airports as well as an analysis of ways to provide a landside connection to the Light Rail service. This study included an existing conditions analysis related to each light rail alternative along a specified conceptual alignment, an operating plan, capital and operating cost estimates and development of schematic-level design options at many of the most challenging areas of each route.

Kerrville Subdivision Use Study – Mr. Rodriguez was tasked with managing a team of transportation professionals who were responsible for performing a thorough examination of a freight railroad short line owned and operated by Union Pacific, called the Kerrville Subdivision. The purpose of the study was to understand the condition of the railroad and determine the feasibility of its eventual conversion to a public transportation facility including Commuter Rail, Light Rail or Bus Rapid Transit; or, a hike and bike trail facility. Should the short line ever be abandoned, this document provides potential solutions for considering a number of alternative treatments, including challenges, opportunities and costs of each. It also provides a series of case studies about various short line railroads across the country that have been acquired by a local or regional agency and adapted for a different use.

Robert Thompson Station Area Vision Plan – Mr. Rodriguez served as the Project Manager for this effort, which was primarily focused on gaining an understanding of market conditions and development potential in the immediate vicinity of VIA's Robert Thompson Transit Station. Partnered with a private developer, VIA was in the process of redesigning the facility to serve as a joint development venture and wanted to gain a better understanding of the greater development potential in the area for which their project would serve as a catalyst. The plan includes an economic and demographic framework that outlines current housing and retail market potentials, which then informs a conceptual plan that illustrates how these market conditions can be realized as a vibrant urban community, oriented around a public transportation investment.

VIA Villa Vision Plan - Mr. Rodriguez served as Project Manager for this effort, which was primarily focused on understanding the spatial and infrastructural requirements for implementing major public transit services to VIA's Centro Plaza on the west end of downtown

San Antonio. VIA Villa is centered on Centro Plaza and the historic International & Great Northern Rail Depot. While Centro Plaza currently serves almost 4,000 daily trips on 17 bus routes, the community dialogue often includes ideas of adding inter-city bus and various passenger rail services while sharing a constrained space with one of the region's busiest and fastest growing freight railroads. The Vision Plan is meant to inspire the community and act as a tool for facilitating dialogue about future growth and development in the area.

Transit Supportive Land Use Guidance – Mr. Rodriguez served as Project Manager for the development of several tools for local governments, agencies and developers to use when establishing independent strategies for development and investment policies related to transportation infrastructure and supportive of transit use. This guidance was proposed to position San Antonio to be more competitive for various Federal grants for transit infrastructure and to encourage developers of new projects to facilitate access to transit as a viable travel option for their end user.

*Strategic Plan for Transit Station Areas in the Greater San Antonio Region* – the focus of this plan is to provide an applied framework for considerations that are relevant to creating station area plans related to VIA's Rapid Transit Corridors. City of San Antonio was the first City to develop its own framework, SA Corridors, as a result of this work.

*Guide to Transit Supportive Land Use* – this is a general guidance document that communicates the opportunities, benefits and components of Transit Supportive Land Use for a broad audience.

*Transit Supportive Land Use Toolkit* – this is a compilation of best practices, recommendations and implementation steps for establishing transit supportive land use policies. It includes an evaluation of current policies in various municipalities in the greater San Antonio region.

VIA Strategic Planning Processes and Procedures – Mr. Rodriguez was the sole author of VIA's process and procedures document for the Strategic Planning Department. The purpose of this document was to provide a consistent and objective, documented approach to how VIA engages the planning process for each project with regard to research, incorporation of the latest best-practices and ultimately keeping the Long Range Plan up to date, which frames the agency's Capital Improvement Program. The document serves as guidance for Strategic Planning staff and for maintaining consistency among various contracted staff that participate and assist with these activities.

San Antonio Modern Streetcar Project – Mr. Rodriguez served as VIA's Project Manager for the local Modern Streetcar project from its initial feasibility study through project development over a 5-year period. Over the course of developing this project, Mr. Rodriguez took a leadership role in building a foundation for interagency coordination on transit and development investment initiatives within the City thereafter. He was directly involved in each step of the process as outlined below:

*Inner-City Rail Streetcar Feasibility Study* – the focus of this effort was to determine the feasibility of implementing a rail streetcar in the downtown San Antonio environment. This

included opportunities related to how new proposed developments, existing community assets and prevailing travel patterns could all be connected by an urban circulator network.

*Economic Impact of Streetcar in San Antonio* – as the feasibility study drew to completion, this study was commissioned to determine what the economic impact of constructing a streetcar would have on San Antonio's local economy from a job creation/sales revenue perspective and an ad valorem revenue/value capture point of view.

*Urban Corridor Alternatives Analysis* – the focus of this effort was to determine specific preferred alignments for 3 generally feasible streetcar routes through downtown San Antonio and gain a better understanding of possible environmental impacts and primary cost drivers. This resulted in defining 3 separate preferred streetcar routes through downtown.

*Streetcar Project Development* – the primary deliverable for this aspect of the project included a 30% design submittal and a Draft Environmental Assessment. Other topics covered during the Project Development process included vehicle specification, design of a vehicle maintenance facility, utility relocation plans, urban design around stations and coordination with Federal Transit Administration Region VI.

VIA Downtown Service Plan – Mr. Rodriguez served as the Project Manager for this effort, which was intended to evaluate multiple transit routing configurations for the entirety of VIA's 48 bus routes operating in downtown San Antonio. The plan investigated impacts and opportunities associated with restructuring routes related to passenger waiting amenities, transit ridership, overall traffic operations and the possibility of increasing service levels over time in one of the busiest and rapidly growing districts in the region.
