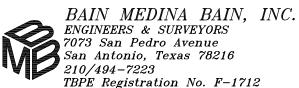
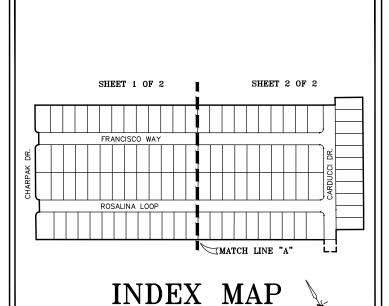


### LOCATION MAP NOT TO SCALE

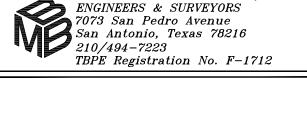


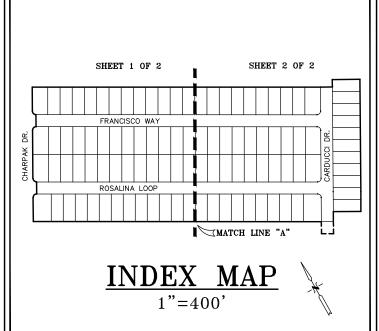
# LOCATION MAP
