

ORDINANCE

**DECLARING AS SURPLUS AND AUTHORIZING DISPOSITION BY
SALE OR CONVEYANCE OF FORMER FIRE STATION 18 LOCATED
AT 1463 SOUTH W.W. WHITE ROAD IN COUNCIL DISTRICT 2, AND
AUTHORIZING STAFF TO DETERMINE THE SALES PRICE AND
FUTURE USE IN COORDINATION WITH COUNCIL DISTRICT 2.**

WHEREAS, the City of San Antonio owns former Fire Station 18 located at 1463 South W.W. White Road; and

WHEREAS, the San Antonio Fire Department has requested former Fire Station 18 to be declared surplus to the needs of the City of San Antonio so that the City can sell or convey the property in the future; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is authorized to take all necessary actions associated with the sale and disposition of the City-owned, former Fire Station 18 located at 1463 South W.W. White Road. Maps and pictures are set forth on **Exhibit A**.


SECTION 2. Funds generated by this ordinance will be deposited into the City's General Fund 11001000, Internal Order 223000000XXX and General Ledger 4903101.

SECTION 3. The disposition of surplus property must be coordinated through the City's Finance Department to assure the removal of these assets from the City's financial records and to record the proper accounting transactions.


SECTION 4. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 5. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.


