AN ORDINANCE 2018-04-12-0266

AMENDING THE CITY CODE OF SAN ANTONIO, CHAPTER 3, ENTITLED "AIRPORTS" AND CLARIFYING RATES FOR THE SAN ANTONIO AIRPORT SYSTEM.

* * * * * *

WHEREAS, the City of San Antonio is the owner and operator of the San Antonio International Airport and Stinson Municipal Airport, and has authority to promulgate rules and regulations that promote the safe and efficient operation of the airports; and

WHEREAS, rules and regulations for the airports set the laws and standards for all persons, businesses, and tenants conducting operations at San Antonio International Airport and Stinson Municipal Airport, and are contained in Chapter 3, Article II of the City Code of San Antonio, last amended in 2015; and

WHEREAS, Aviation staff recommends updating Chapter 3, Article II of the City Code by adding new provisions to reflect current airport practices and rates, and revising existing provisions to reflect federal, state, and local standards; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Chapter 3 Article II of the City Code of San Antonio, Texas entitled "Airports" is amended by adding language underlined and deleting language bracketed and stricken to the existing provisions as set out in **Attachment 1** to this Ordinance. All other provisions of Chapter 3 of the City Code of San Antonio, Texas remain in full force and effect unless expressly amended by this ordinance.

SECTION 2. Should any article, section, part, paragraph, sentence, phrase, clause, or word of this ordinance for any reason be held illegal, inoperative, or invalid, or if any exception to or limitation upon any general provision in this ordinance is held to be unconstitutional or invalid or ineffective, the remainder shall, nevertheless, stand effective and valid as if it had been enacted and ordained without the portion held to be unconstitutional or invalid or ineffective.

SECTION 3. The publishers of the City Code of San Antonio, Texas are authorized to amend the code to reflect the adopted changes and to correct typographical errors and to index, format and number paragraphs to conform to the existing code.
