AN ORDINANCE 2018 - 04 - 19 - 0292

AUTHORIZING THE SETTLEMENT OF A LAWSUIT STYLED DAVID BRIAN RICKS V. CITY OF SAN ANTONIO, ET AL, CAUSE NUMBER 15-CV-00251-RCL IN THE UNITED STATES DISTRICT COURT, WESTERN DISTRICT OF TEXAS, SAN ANTONIO DIVISION IN THE AMOUNT OF \$165,000.00.

WHEREAS, David Brian Ricks filed a lawsuit against the City of San Antonio alleging civil rights violations arising out of events that occurred on April 6, 2013 in San Antonio; and

WHEREAS, it is in the City's best interest to settle this matter to avoid the uncertainty and risks associated with further litigation; and

WHEREAS, the parties have reached a mutual agreement to settle all claims for the amount of \$165,000.00 payable from the Self-Insurance Liability Fund subject to City Council approval; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The amount of \$165,000.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund, General Ledger 5402530 General Liability Claims, Cost Center 7509020001 Risk Management-Liability, and is authorized to be made payable as follows: \$165,000.00 will be paid to plaintiff David Brian Ricks as settlement of Cause Number 15-CV-00251-RCL styled David Brian Ricks v. City of San Antonio.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
