## AN ORDINANCE

AUTHORIZING THE ACCEPTANCE OF AN ADDITIONAL \$43,500.00 FROM THE OFFICE OF NATIONAL DRUG CONTROL POLICY FOR THE HIGH INTENSITY DRUG TRAFFICKING AREA (HIDTA) GRANT TO INCREASE ORIGINAL FUND AWARD TO THE SAN ANTONIO HIDTA INITIATIVE FOR THE GRANT PERIOD JANUARY 1, 2017, THROUGH DECEMBER 31, 2018.

**WHEREAS**, pursuant to Ordinance 2016-08-04-0549, the City of San Antonio accepted a San Antonio High Intensity Drug Trafficking Area (HIDTA) Initiative grant from the Office of National Drug Control Policy (ONDCP); and

WHEREAS, pursuant to Ordinance 2017-08-31-0607, an additional \$1,025.00 in funds was accepted, and

WHEREAS, the ONDCP has offered additional grant funds in an amount up to \$43,500.00; and

WHEREAS, no matching contribution is required; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or her designee, or the San Antonio Chief of Police or his designee, is authorized to accept additional grant funds in an amount of \$43,500.00 to increase the grant award to \$2,083,610.00 from the Office of National Drug Control Policy for a High Intensity Drug Trafficking Area grant for the period beginning January 1, 2017 through December 31, 2018.

**SECTION 2.** The City Manager or her designee, or the San Antonio Chief of Police or his designee, is further authorized to execute any and all necessary documents to effectuate said acceptance.

**SECTION 3.** Upon acceptance, \$43,500.00 from ONDCP will be appropriated into Fund 2202817003. The proposed amended budget, which is attached and incorporated in this Ordinance for all purposes as **Exhibit A**, is approved.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers,
