ORDINANCE

APPROVING THE FOLLOWING PURCHASES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$1,943,000.00: (A) TEXAN WASTE EQUIPMENT INC. DBA HEIL OF TEXAS AND RELIANCE TRUCK & EQUIPMENT, LTD. FOR REFUSE TRUCK BODY PARTS; (B) FOX TRUCK WORLD LLC FOR ROTOBEC GRAPPLER PARTS; AND (C) HESSELBEIN TIRE SOUTHWEST FOR POLICE PURSUIT TIRES.

WHEREAS, bids were submitted to provide the City of San Antonio with commodities and services on an annual basis for the terms of the contracts; and

WHEREAS, this ordinance approves the following contracts: (A) Texan Waste Equipment Inc. dba Heil of Texas and Reliance Truck & Equipment, Ltd. for refuse truck body parts; (B) Fox Truck World LLC for Rotobec grappler parts; and (C) Hesselbein Tire Southwest for police pursuit tires; and

WHEREAS, the bid submitted by Fox Truck World LLC (Items 1 and 2) failed to meet the City's specifications and/or requirements for refuse truck body parts; and

WHEREAS, Texas Local Government Code section 271.102 provides for the City's participation in cooperative purchasing programs and such purchases satisfy any state law requiring competitive bidding; and

WHEREAS, this ordinance approves two low qualifying bid contracts, one low bid contract and one contract procured utilizing cooperative purchasing; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following bids to furnish the City with goods and services on an annual basis as shown on the attached bid tabulation sheets are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements: (A) Texan Waste Equipment Inc. dba Heil of Texas and Reliance Truck & Equipment, Ltd. for refuse truck body parts; (B) Fox Truck World LLC for Rotobec grappler parts; and (C) Hesselbein Tire Southwest for police pursuit tires. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. It has been found and declared that the bid submitted by Fox Truck World LLC (Items 1 and 2) for refuse truck body parts failed to meet the City's specifications and/or requirements.

SECTION 3. Funds will be encumbered upon issuance of purchase orders and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2018 budget and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

SECTION 4. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
