## AN ORDINANCE 2018-05-17-0353

RATIFYING THE SUBMISSION OF A GRANT APPLICATION AND AUTHORIZING THE ACCEPTANCE OF FUNDS UPON AWARD OF AN AMOUNT NOT TO EXCEED \$2,293.64, FROM THE TEXAS HISTORICAL COMMISSION FOR TRAVEL STIPENDS TO THE NATIONAL ALLIANCE OF PRESERVATION COMMISSION'S FORUM 2018 CONFERENCE.

WHEREAS, the Office of Historic Preservation staff has been selected to present at two sessions during the FORUM Conference ("Conference") in Des Moines, Iowa, July 18 - 22, 2018; and

WHEREAS, as part of its Certified Local Government (CLG) program, the Texas Historical Commission is offering travel stipends for CLG representatives to attend the Conference; and

WHEREAS, as a participating CLG, staff members of the City's Office of Historic Preservation qualify for stipends which allow for reimbursement of travel costs to the Conference; and

**WHEREAS**, the Conference focuses on the needs and issues faced by preservation commissions and commission staff and offers valuable training related to staffing the Historic and Design Review Commission; **NOW THEREFORE**:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The submission of a grant application to the Texas Historical Commission and the acceptance of funds in an amount up to \$2,293.64 is hereby ratified. A copy of said grant application which is incorporated herein for all purposes is on file with the Office of Historic Preservation.

**SECTION 2.** Upon award, a new fund and internal order will be created for use in the accounting for the fiscal transaction in the acceptance of this grant and the amount listed above totaling a sum not to exceed \$2,293.64 will be appropriated in said fund. A formal final budget which will include Internal Order numbers and General Ledger numbers will be submitted by the department upon award.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.
