AN ORDINANCE

AUTHORIZING THE ACCEPTANCE OF A DONATION IN AN AMOUNT UP TO \$398,053.00 FROM THE **SOUTHWEST** TEXAS **REGIONAL ADVISORY COUNCIL FOR TRAUMA FOR USE BY THE MOBILE** INTEGRATED **HEALTHCARE** UNIT OF THE EMERGENCY MEDICAL SERVICES DIVISION OF THE SAN ANTONIO FIRE DEPARTMENT FOR ELIGIBLE **EXPENSES** INCLUDING SUPPLIES. EXPENSES. **OPERATIONAL EDUCATION** AND TRAINING, EQUIPMENT, VEHICLES AND **COMMUNICATIONS EQUIPMENT.**

WHEREAS, the Southwest Texas Regional Advisory Council for Trauma (STRAC) has informed the San Antonio Fire Department (SAFD) of its intention to donate funds in the amount of \$33,639.60 to be used by the Mobile Integrated Healthcare (MIH) Unit of the Emergency Medical Services (EMS) Division of SAFD for eligible expenses including supplies, personnel and operational expenses, education and training, equipment, vehicles and communications equipment; and

WHEREAS, the donated funds will be used to help improve the health and daily activities of citizens utilizing services at Haven for Hope and reduce admissions and/or readmissions to hospital Emergency Rooms throughout the city for the period of January 1, 2018 through December 31, 2018.

WHEREAS, no cash or in-kind matching contributions are required; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The donation to the City in an amount up to \$398,053.00 from the STRAC, to be used by the Mobile Integrated Healthcare (MIH) Unit of the Emergency Medical Services (EMS) Division of SAFD for eligible expenses including supplies, personnel and operational expenses, education and training, equipment, vehicles and communications equipment, to be used to help improve the health and daily activities of citizens utilizing services at Haven for Hope and reduce admissions and/or readmissions to hospital Emergency Rooms throughout the city for the period of January 1, 2018 through December 31, 2018is hereby accepted.

SECTION 2. A copy of a letter from STRAC to SAFD regarding this donation and setting forth certain specifics regarding the use of the donated funds is attached hereto as **Attachment 1** and made a part hereof for all purposes. The City Manager or her designee, or the Fire Chief or his



designee, are each hereby autholized to execute any and all additional documents necessary to effectuate and evidence the acceptance of the donation and/or perform the programs for which the funds will be used.

SECTION 3. Fund 29820000 and Internal Order 82000000024 are hereby designated for use in the accounting for the fiscal transaction in the acceptance of this donation.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Deputy Chief Financial Officer ("DCFO"), City of San Antonio. The DCFO may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
