
#### Abstract

APPROVING THE PURCHASE OF FITNESS EQUIPMENT FOR various san antonio fire department facilities from WHEELS AND FITNESS IN MOTION OF SOUTH TEXAS, LLC DBA FITNESS IN MOTION AND BSN SPORTS FOR A TOTAL COST OF $\mathbf{\$ 1 6 7 , 0 2 8 . 7 1}$, FUNDED FROM THE GENERAL FUND.


WHEREAS, bids were submitted to provide the City of San Antonio with fitness equipment for 41 San Antonio Fire Department (SAFD) facilities; and

WHEREAS, the new equipment will replace outdated, damaged or broken equipment which first responders use to better prepare for the daily physical demands of their job duties; and

WHEREAS, the bids submitted by BSN Sports (Items 4, 57 and 111) failed to meet the City's specifications and/or requirements; and

WHEREAS, the bid submitted by Wheels and Fitness in Motion of South Texas, LLC DBA Fitness in Motion (Item 95), a City Business as defined by the City's Local Preference Program, is within 3 percent of the lowest bid, which was from BSN Sports, a bidder which is not a City Business; and

WHEREAS, the low responsive bids were submitted by Fitness in Motion (Items 1-15, 35-61, and 64-112) for a total cost of $\$ 160,821.31$ and BSN Sports (Items 16-34, 62 and 63) for a total cost of \$6,207.40; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The low responsive bids from Fitness in Motion (Items 1-15, 35-61, and 64-112) and BSN Sports (Items $16-34,62$ and 63) to provide the City of San Antonio with fitness equipment for SAFD for a total cost of $\$ 167,028.71$ are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as Exhibit I. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. It has been found and declared that the bids submitted by BSN Sports (Items 4, 57 and 111) for fitness equipment for SAFD failed to meet the City's specifications and/or requirements.

SECTION 3. It has been found and declared that, pursuant to the City's Local Preference Program, passed by ordinance number 2013-03-21-0167 and as amended by ordinance number 2014-11-13-0923, Fitness in Motion, a City Business, is entitled to award of item 95.

SECTION 4. Funding for this ordinance in the amount up to $\$ 167,028.71$ is available in Fund 11001001, Cost Center 2015090001, and General Ledger 5501055, as part of the Fiscal Year 2018 Budget.

SECTION 5. Payments not to exceed the budgeted amounts are authorized to Fitness in Motion and BSN Sports and should be encumbered with purchase orders.

SECTION 6. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 7. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
