## **ORDINANCE**

AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$720,000.00: (A) HAYS CITY CORPORATION AND DISTRIBUTORS, HAMPEL OIL INC. **FOR ENGINE** LUBRICANTS; (B) SOUTHWEST PUBLIC SAFETY FOR INSTALLS, REMOVALS, AND REPAIRS OF EQUIPMENT FOR POLICE MOTORCYCLES; (C) FOUR WINDS INTERACTIVE, LLC FOR FOUR **SOFTWARE MAINTENANCE** AND **SUPPORT** CONVENTION AND SPORTS FACILITIES; AND (D) KFT FIRE TRAINER, LLC FOR MAINTENANCE AND SUPPORT SERVICES FOR THE STRUCTURAL FIRE TRAINER T2000 TRAINING SIMULATOR.

WHEREAS, bids were submitted to provide the City of San Antonio with commodities and services on an annual basis for the terms of the contracts; and
