DECLARING AS SURPLUS TWO HANGARS AND ONE BUILDING LOCATED AT 10440 JOHN CAPE ROAD AT SAN ANTONIO INTERNATIONAL AIRPORT AND AUTHORIZING THE DEMOLITION OF ALL THREE STRUCTURES.

WHEREAS, the City of San Antonio owns two parcels of land with two hangars and one additional building located at 10440 John Cape Road at the San Antonio International Airport which are currently not leased to any tenant and have been unoccupied and unused since 2013;

WHEREAS, WesternSATLeasing wishes to lease those parcels, demolish the three existing structures located there and construct new hangar facilities to sublease to other tenants; and

WHEREAS, SAT seeks to have the City Council declare these three structures surplus and authorize their demolition; NOW THEREFORE,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The three structures located at 10440 John Cape Road at San Antonio International Airport are declared surplus, and their demolition is authorized.

**SECTION 2.** WesternSATLeasing will be responsible for all demolition activities. There is no fiscal impact to the City.

**SECTION 3.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
