## AN ORDINANCE 2018-06-14-0449

AUTHORIZING AN AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT WITH THE NORMANDY GROUP TO EXTEND THE CONTRACT TERM THROUGH THE END OF THE CALENDAR YEAR AT THE MONTHLY RATE OF \$10,000.00 FOR FEDERAL LEGISLATIVE SERVICES, INCLUDING SUPPORTING EFFORTS FOR THE ACQUISITION OF A NON-STOP FLIGHT BETWEEN THE SAN ANTONIO INTERNATIONAL AIRPORT AND REAGAN NATIONAL AIRPORT, FOR THE SAN ANTONIO AIRPORT SYSTEM.

**WHEREAS** in January 2018 the City entered into a short-term Professional Services Agreement with The Normandy Group for federal legislative services; and

WHEREAS, the primary goal of this agreement was to facilitate changes to the Federal Aviation Administration Reauthorization Bill enabling the acquisition of a non-stop flight between San Antonio International Airport and Reagan National Airport in Washington, D.C.; and

WHEREAS, the United States Congress has not yet voted on this bill; and

WHEREAS, the Professional Services Agreement with The Normandy Group has expired, and the City wishes to extend the contract for a period of seven months, or until such time as the United States Congress votes on the bill, if sooner; and

WHEREAS, it is now necessary to authorize the execution of an amendment to the Professional Services Agreement with The Normandy Group, extending the term for seven months at the monthly rate of \$10,000.00; NOW THEREFORE,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The terms and conditions of the Amendment to the Professional Services Agreement for Federal Representation Services with The Normandy Group for a term of seven months at the monthly rate of \$10,000.00 are approved. The City Manager or her designee is authorized to execute the Amendment, a copy of which is set out in **Exhibit 1.** 

**SECTION 2.** Funding for this ordinance in the amount of \$70,000.00 is available in Fund 51001000, Cost Center 3305010001 General Ledger 5201040 as part of the Fiscal Year 2018 Budget. Additional funding for this ordinance is contingent upon City Council approval of the City's operating budget and the availability of funds for subsequent Fiscal Years.

**SECTION 3.** Payment not to exceed the budgeted amount is authorized to The Normandy Group and should be encumbered with a purchase order.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

## AMENDMENT NO. 1 TO PROFESSIONAL SERVICES AGREEMENT FOR FEDERAL REPRESENTATION SERVICES

This Amendment (hereinafter called the "Amendment") to the Professional Services Agreement for Federal Representation Services for the San Antonio International Airport is entered into by and between the City of San Antonio (herein called the "City"), a Texas municipal corporation, acting by and through its City Manager, and The Normandy Group (hereinafter called "Consultant"), acting by and through its duly authorized corporate representative, as set out below. WITNESSETH:

WHEREAS, on February 20, 2018, the City and Consultant entered into a Professional Services Agreement for Federal Representation Services for the San Antonio International Airport System. (Hereinafter called the "Agreement"); and

WHEREAS, the primary goal of this contract was to facilitate the acquisition of a non-stop flight between San Antonio International Airport and Ronald Reagan Washington National Airport; and

WHEREAS, the Federal Legislature has yet to pass legislation regarding the DCA/Reauthorization Bill which would facilitate the institution of that flight; and

WHEREAS, the current contract expires on May 30, 2018; and

WHEREAS, the City wishes to extend this contract for an additional seven months to allow for continuity of service through final resolution of this issue; and

WHEREAS, Consultant has agreed to continue operation under the existing fee structure of the Agreement for an additional seven month period; and

WHEREAS, it is now necessary to amend the Agreement to extend the term for an additional seven month period; and

NOW THEREFORE, in consideration of the terms, covenants, agreements and demises herein contained, and in consideration of other good and valuable consideration, each to the other given, the sufficiency and receipt of which are hereby acknowledged, the Agreement entered into by and between the City and the Consultant is amended as follows:

1. Article II, TERM. The following section is added to Article II, extending the term for a period of seven months:

"Upon approval by the City Council of the City of San Antonio, the term of this Agreement is extended for a period of seven (7) additional months, commencing

on June 1, 2018 and terminating on December 31, 2018, unless sooner terminated in accordance with the provisions of this Agreement."
