# Overview

- December 2008:
  - Military Lighting Overlay District (MLOD) ordinance established
- Camp Bullis (MLOD-1) Applies to:
  - 5-mile area around installation
  - Residential and commercial uses
  - Outdoor signs and street lights







## Overview

- Existing MLOD requires:
  - Downward light fixtures for outdoor
  - Regulates lighting intensity
  - Restricts outdoor lighting after 11:00 PM
    - With some exceptions
  - Variances and special exceptions are considered by the Board of Adjustment (BOA)



#### **Proposed Amendments**



- MLR 1 0-3 miles around the installation (most restrictive)
- MLR 2 3-5 miles around the installation
  - Regulate:
    - BUG Ratings
    - Lumens
    - Correlated Color





#### **Proposed Amendments**

- Ordinance sets light intensity requirements in Industry terms
  - Maximum Lumen Levels
  - Vertical Illuminance
  - Lighting Plans Required for Permitting
  - Added Definitions for clarity
- Maximum allowable light levels vary according to zone and use








## Implementation Strategy

- Update Ch. 35 (UDC) to incorporate MLOD changes
- Rezone areas to update/incorporate MLOD:
  - Camp Bullis (update)
  - Lackland AFB & Medina Training Annex (establish)
- Coordinate with Bexar County, Military, and AACOG to adopt finalized amendments with other municipalities around Camp Bullis, Lackland, and Randolph AFB (with applicable study)
