### Budget Narrative

**Personnel:** One (1) SAPD Lieutenant-Project Director: Serves as the Project Director. Responsibilities include the overall administration and operation of the ReACT Task Force, and accountable for the Unit's overall efficiency and effectiveness. In addition, ensures that Task Force activities are documented, recorded, and submitted in accordance to ABTPA guidelines. This position spends 100% of time on task force related issues. 1 Position: 100% of salary funded by COSA as an In-Kind Match

Two (2) SAPD Sergeants-Supervisors: Responsible for the first line supervision of the investigators and civilian personnel assigned to the unit. Additional responsibilities are assigning cases, responding to sensitive concerns of citizens, coordinating exhibits, staffing, providing media interviews, noting details of unit activity, and providing attentive first line supervision through participative leadership. These 2 positions spend 100% of time on task force related issues. 2 Position: 100% of salary funded by COSA as an In-Kind Match

Eighteen (18) SAPD Detectives: Responsibilities are to perform criminal investigations, conduct salvage and dealer inspections, develops intelligence information, prepares and execute arrest and search warrants, performs fixed and mobile surveillance on covert operations, and identifies and arrest suspects. Takes part in specialized areas within the task force such as operating the License Plate Recognition (LPR) System, conducting auto theft/burglary/prevention training to law enforcement personnel, and conducting public awareness presentations. These 18 positions spend 100% of time on task force related issues. 7 Positions: 80% of salaries funded by ABTPA 20% of salaries funded by COSA as Cash-Match 11 Positions: 100% of salaries funded by COSA as an In-Kind Match

One (1) SAPD Administrative Assistant II-Project Manager-Civilian Position: This position assists the Program Director with the day-to-day operation of the project. Responsibilities include record keeping and maintaining project files, reviewing financial expenditures, approving and submitting required reports. Evaluates the project, assists with audits, monitors inventory levels, maintains office equipment, prepares expenditures and coordinates travel. This position spends 100% of time on task force related issues. 1 Position: 80% of salary funded by ABTPA 20% of salary funded by COSA as Cash-Match

## Budget Narrative

Two (2) SAPD Administrative Assistant I-Civilian Positions: Ensure SAPD adheres to TCIC/NCIC Rules and Regulations, safeguarding classified stolen auto records. In addition, reviewing initial cases for solvability factors, verifying reports for accuracy, processing recovery notifications, and ensuring validations are performed as required by NCIC 2000. These 2 positions spend 100% of time on task force related issues. 1 Position: 80% of salary funded by ABTPA 20% of salary funded by COSA as Cash-Match 1 Position: 100% of salary funded by COSA as an In-Kind Match

**Overtime:** Overtime funds are used when task force members work beyond the normal 40 hour work week on task force related operations, such as assisting other agencies and departments within the San Antonio Police Department requesting ReACT 's vehicle identification expertise. In addition, overtime hours include sting operations, warrant round-ups, interviewing suspects, wrecker enforcement, conducting public awareness presentation on auto theft/burglary of vehicles, and providing auto theft/burglary of vehicle training sessions to law enforcement personnel and other task force related activities.

*The Regional Auto Crimes Team (ReACT) Task Force is a multi-jurisdictional, multi-dimensional law enforcement unit in the San Antonio Police Department. It is composed of officers from the San Antonio Police Department (SAPD), the Bexar County Sheriff's Office (BCSO), and the National Insurance Crime Bureau (NICB). Together the task force has 25 law enforcement officers with extensive training in auto theft investigations. Most task force members have attended basic and intermediate auto theft investigation training, including complex crimes training and title fraud training. The ReACT Task Force combines resources, intelligence and conserves both fiscal and investigative resources for the city and the county.*

*ReACT propose to reduce vehicle crimes throughout Bexar County and the surrounding areas by collaborating with law enforcement agencies within Bexar County and the surrounding counties by conducting covert operations, surveillance, salvage yard and business inspections and sharing intelligence of prolific offenders.*

*The ReACT Task Force and the National Insurance Crime Bureau agent work closely together by providing intelligence information, leads and working as a liaison for insurance companies.*

*The REACT Task Force provides assistance to various law enforcement agencies and other departments within the San Antonio Police Department to identify suspects involved in motor vehicle thefts and provide assistance in the recovery of stolen vehicles and stolen property. The task force also provides investigative and technical assistance to agencies within our service area on auto theft, vehicle burglaries and insurance fraud cases.*

*The ReACT Task Force serves the community needs by combating vehicle crimes through the investigation of motor vehicle thefts, the recovery of stolen vehicles and their parts, the recovery of stolen property taken from vehicles and a timely return of recovered items and vehicles to their rightful owners. These needs are accomplished by the coordination and sharing of intelligence related to auto thefts and auto burglaries with other agencies and by performing crime prevention training to law enforcement personnel and the public.*

*The ReACT Task Force will conduct vehicle theft/burglary of a vehicle public education/awareness events that will influence the community to safeguard their vehicles and personal property through the use of practical prevention methods.*

### Grant Problem Statement

- 2.1 Provide an assessment of the motor vehicle burglary (including theft of parts) problem in the coverage area of this application.

*In 2017, the San Antonio Police Department received 19,475 burglary of motor vehicle reports, an increase of 8.08% from 2016.*

*In 2017, the San Antonio Police Department received 4,783 burglary of motor vehicle parts, a decrease of 16.19% decrease from 2016.*

*Contributing factors that lead to burglary of vehicles includes vehicle owners leaving valuable items in plain view inside vehicles and leaving their vehicles unlocked. Items stolen during vehicle burglaries are turned into profit at flea markets, pawn shops, garage sales, and online classified ads. Victims leave their keys in the vehicle and their motors running giving criminals the opportunity to steal their car and stripping the vehicle for parts. Each month the ReACT Task Force finds chop shops where the victims' vehicles are found dismantled.*

- 2.2 Provide an assessment of the motor vehicle theft problem in the coverage area of this application

*In 2017, the San Antonio Police Department reported 7,144 vehicles stolen, a decrease of 1.23% or 89 vehicles from 2016.*

*Texas has 13 major border crossings. Nine of these are direct routes leading to two primary interstate highways through San Antonio. Commerce from the United States and Mexico use Bexar County and San Antonio as a transportation hub for legitimate industry.*

*Vehicle crimes continue to impact the community from various aspects; vehicles are being stolen from rental car agencies, targeted by auto theft rings by using fraudulent credit cards to victimize businesses. Vehicles are stolen from car dealerships and auto auctions by obtaining access to the key or key fob and by fraudulent means.*

*Vehicle crimes are a rapidly evolving criminal endeavors managed by Mexican cartels, drug rings, and criminal street gangs. Given the fact that the Mexican border is a short distance away, this gives criminals the opportunity to cross into Mexico before the vehicle is reported stolen. Mexican cartels and gangs like the durability of heavy-duty pickups because they allow for escape through rough terrain which law enforcement is unable to pursue through. Stolen vehicles are used as a gateway to execute other crimes. The most popular benefit is transporting illegal contraband. Cartels and criminal gangs continue to transport drugs, weapons, cash, and human cargo between the U.S. and Mexican border. It is becoming an increasingly dangerous endeavor as the violence between rival gangs spills into the United States.*

Bexar County has 23 incorporated cities, 7 unincorporated communities and rural areas. Four (4) Interstate Highways, 4 U.S. Highways, 2 State Highways, and 2 Loops run through San Antonio, making it an ideal transportation hub. In addition, four (4) active military installations and 1 military medical center are located in the city.*

*The counties adjacent to Bexar County are Kendall County (north), Comal County (north), Guadalupe County (northeast), Wilson County (southeast), Medina County (west), and Bandera County (northwest).*

*The Regional Auto Crimes Task Force (ReACT) is a multi-jurisdictional law enforcement task force that includes the San Antonio Police Department, the Bexar County Sheriff's Office, and the National Insurance Crime Bureau. Together these agencies are housed under one umbrella located at the San Antonio Police Vehicle Crimes Office. The ReACT goals for this multi-agency collaboration are the same, to reduce vehicle thefts and burglary of a vehicle; to reduce the sale of stolen vehicles or parts through enforcement, the detection and apprehension of criminals, and to conduct public awareness through crime prevention and educational presentations.*

*The San Antonio Police Vehicle Crimes command structure is as follows: The Chief of Police, Assistant Chief, Deputy Chief, Captain, Vehicle Crimes Lieutenant, 2 Vehicle Crimes Sergeants, 18 Vehicle Crimes Detectives, and 3 Administrative Assistants.*

*The Bexar County Sheriff's Office command structure is as follows: The Sheriff of Bexar County, Chief Deputy, Deputy Chief, Captain, Lieutenant, Auto Theft Sergeant, 3 Auto Theft Investigators.*

*The National Insurance Crime Bureau command structure is as follows: Chief Executive Officer, Chief Operating Officers, Chief Inspector,/Compliance Officer, Chief of Staff, Senior Management and NICB Agents.*

##### **3.1 Functions of the Proposed Program Related to Burglary of a Motor Vehicle**

*The function of the proposed program is to reduce the burglary of motor vehicles through law enforcement investigations, by identifying, arresting, and successfully charging criminals and includes crime prevention techniques through public education/awareness presentations. Task force members will work with surrounding county and local jurisdictions to help identify known burglary of vehicle offenders and will share intelligence as it relates to these criminals. Task force members will monitor both brick and mortar locations known to deal in stolen property and online sites to recovery stolen property before the criminals can profit from their crimes. Problem locations will be targeted for covert operations and multi agency cooperation with be coordinated as a force multiplier. By meeting the goals and strategies stated in this proposal the task force will reduce burglary of motor vehicles by making timely arrests, recovering stolen property thereby reducing the profitability of the crime and clearing cases. Specifically, Task Force Detectives will respond to requests for assistance from Property Crimes Detectives assigned to the six police substations in San Antonio and who are not assigned to the task force.*

##### **3.2 Functions of the Proposed Program Related to Theft of a Motor Vehicle**

*The function of the proposed program is to reduce the theft of motor vehicles through law enforcement investigations, by identifying, arresting, and successfully charging criminals and includes crime prevention techniques through public education/awareness presentations. Intelligence sharing and force multiplying as it relates to covert operations and investigations will be achieved through inter-agency cooperation with surrounding counties and jurisdictions. The monitoring of online sites that sell stolen property and timely implementation of sting operations will lead to an increase in arrests and recovery of stolen property and reduce the profitability of criminal participation in vehicle crimes. By meeting the goals and objectives stated in this proposal the task force will reduce the theft of motor vehicles by making timely arrests, recovering stolen property thereby reducing the profitability of the crime and clearing cases. Specifically, Task Force Detectives will*

*conduct follow-up investigations in all arrest cases involving stolen motor vehicles, all suspect cases in which solve-ability factors exist, 68A and VIN Inspections, Salvage Inspections, Covert Operations, Inter Agency Cooperation, Intelligence Sharing, Social Media Investigations, Pawn Shop and Flea Market observations, VIN Etchings and Crime Prevention Education.*

### 3.3 Functions of the Proposed Program Related to Motor Vehicle Burglary and Theft Prevention

*The function of the proposed program is to reduce the theft of motor vehicles and the burglary of vehicles through crime prevention techniques which include public education/awareness presentations both in person and through social media. The in-person presentations are made up of new car buyer clinics, neighborhood association meetings, conventions, static displays at public events, distribution of crime prevention publications and material, VIN etchings, informative citations in public parking lots. The social media outreach will be conducted through multiple Facebook accounts for Bexar County, San Antonio and surrounding agencies that wish to participate. By meeting the goals and strategies stated in this proposal by the task force will reduce the burglary to motor vehicles problem, reduce vehicle theft and increase case clearances.*

*San Antonio is the location for the Southwest Texas Fusion Center which is one of 78 fusion centers in the United States. Inter-agency cooperation allows the task force to act as a conduit for any agency requesting assistance with any number of intelligence related*

*inquiries.*
