AN ORDINANCE 2018-08-02-0575

AMENDING THE LAND USE PLAN CONTAINED IN THE SOUTH CENTRAL SAN ANTONIO COMMUNITY PLAN, A COMPONENT OF THE COMPREHENSIVE MASTER PLAN OF THE CITY, BY CHANGING THE USE OF APPROXIMATELY 01.425 ACRES OF LAND LOCATED AT 740 HOT WELLS BOULEVARD, LEGALLY DESCRIBED AS THE WEST 67.88 FEET OF THE NORTH 200 FEET OF LOT 5A, THE SOUTH 169.6 FEET OF LOT 5A, AND THE NORTH 219.5 FEET OF LOT 32, BLOCK 6, NCB 10938 FROM "LOW DENSITY RESIDENTIAL" TO "COMMUNITY COMMERCIAL".

WHEREAS, the South Central San Antonio Community Plan was adopted on September 20, 2001 by City Council as a component of the City's Comprehensive Master Plan adopted May 29, 1997; and

WHEREAS, the Unified Development Code requires consistency between zoning and the Comprehensive Master Plan and Section 213.003 of the TEXAS LOCAL GOVERNMENT CODE allows amendment of the Comprehensive Master Plan following a public hearing and review by the Planning Commission; and

WHEREAS, a public hearing was held on March 14, 2018 by the Planning Commission allowing all interested citizens to be heard; and

WHEREAS, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The South Central San Antonio Community Plan, a component of the Comprehensive Master Plan of the City, is hereby amended by changing the use of approximately 1.425 acres of land located at 740 Hot Wells Boulevard, legally described as the west 67.88 feet of the north 200 feet of Lot 5A, the south 169.6 feet of Lot 5A, and the north 219.5 feet of Lot 32, Block 6, NCB 10938, from "Low Density Residential" to "Community Commercial". All portions of land mentioned are depicted in **Attachment "I"** attached hereto and incorporated herein for all purposes.

SECTION 2. This ordinance shall take effect August 12, 2018.
