

AN ORDINANCE 2009 - 11 - 19 - 0937

**AUTHORIZING CONVEYANCE OF 10 PARCELS OF
LAND TO THE SAN ANTONIO RIVER AUTHORITY FOR
THE DEVELOPMENT OF THE SAN ANTONIO RIVER
IMPROVEMENTS PROJECT (SARIP) MISSION REACH,
PHASE III AND IV LOCATED IN COUNCIL DISTRICT 3.**

* * * * *

WHEREAS, the City of San Antonio wishes to extend river improvements along what is referred to as the Mission Reach segment of the San Antonio River, which runs from Alamo Street to Loop 410; and

WHEREAS, the San Antonio River Authority has taken the lead in the project in working with the U.S. Army Corps of Engineers and in obtaining funding from the Corps of Engineers; and

WHEREAS, as a condition to the cooperation and funding required from it by the City and the San Antonio River Authority, the Corps of Engineers requires that the San Antonio River Authority have fee title to all real property involved in the project; and

WHEREAS, the City of San Antonio is taking the actions authorized by this ordinance to get the requisite cooperation and funding from the Corps of Engineers, but the City nevertheless must protect its interest in assuring proper river improvements are made and that its citizens have the benefit of the resulting park;
NOW THEREFORE,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
SAN ANTONIO:**

SECTION 1. The following properties belonging to the City of San Antonio ("City Tracts") are declared surplus to the needs of the City of San Antonio:

- Tract I:** An approximately 3.623-acre tract more particularly described on **Attachment I** (Parcel 469523)
- Tract II:** An approximately 2.39-acre tract more particularly described on **Attachment II** (Parcel 469533)
- Tract III:** An approximately 1.921-acre tract more particularly described on **Attachment II** (Parcel 469585)
- Tract IV:** An approximately 6.147-acre tract more particularly described on **Attachment IV** (Parcel 469586)
- Tract V:** An approximately 6.336-acre tract more particularly described on **Attachment V** (Parcel 469587)

- Tract VI:** An approximately 2.360-acre tract more particularly described on **Attachment VI** (Parcel 469595A)
- Tract VII:** An approximately 0.882-acre tract more particularly described on **Attachment VII** (Parcel 469595B)
- Tract VIII:** An approximately 0.076-acre tract more particularly described on **Attachment VIII** (Parcel 476179)
- Tract IX:** An approximately 2.098-acre tract more particularly described on **Attachment IX** (Parcel 476194)
- Tract X:** An approximately 1.137-acre tract more particularly described on **Attachment X** (Parcel 476195)

SECTION 2. The City Manager or her designee, severally, are authorized and directed to procure a survey of the designated tracts permitting them to be described adequate for conveyance, the City Manager or her designee, severally, to determine in the interests of the City the exact boundaries in case of any doubt of the property intended for conveyance. All attachments to the ordinance are incorporated into it for all purposes as if fully set forth.

SECTION 3. The City Tracts are all to be conveyed to the San Antonio River Authority as a part of the Mission Reach river improvements project. Conveyance of the City Tracts is conditioned on the San Antonio River Authority (1) promptly constructing a park satisfactory to City all along the San Antonio River from the Alamo Street crossing on the north to the Loop 410 crossing on the south, (2) perpetually maintaining the park in a condition satisfactory to the City, (3) keeping the park open on all days and for the hours the City of San Antonio's parks are generally open to the public, and (4) not restricting public activities in the park more severely than such activities are restricted generally in the parks of the City of San Antonio. At any time that the San Antonio River Authority materially fails to fulfill any of the above requirements, the City of San Antonio has the right to reenter and assume control of all property conveyed by it under this ordinance. Upon such reentry, San Antonio River Authority's title to the affected property fails, and title reverts in the City of San Antonio. The San Antonio River Authority will have no further rights in the property and no claim for compensation on account of the defeasance, the improvements it may have made to the property, or otherwise.

SECTION 4. The City Manager or her designee, severally, are authorized and directed to execute and deliver all documents and to do all other things conducive to effectuate the actions authorized by this ordinance as to the right of way closures and the City Tracts.

SECTION 5. All attachments are incorporated into this ordinance for all purposes as if they were fully set forth.

SECTION 6. The removal of surplus property must be coordinated through the city's Finance Department to assure the removal of these assets from the City's financial records and to record the proper accounting transactions.


SECTION 7. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 8. This ordinance becomes effective 10 days after passage unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it becomes effective immediately.
