**SUMMARY:**

Mayor Nirenberg established the San Antonio Economic Development Corporation (SAEDC) Applicant Review Committee to address the unprecedented 40 plus applications. The Committee recommended nine (9) Applicants to the Economic and Workforce Development Council Committee for interviews. There are three (3) available slots to fill.
