The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call noting the following Councilmembers present:

- 2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.

Councilmember Saldaña moved to approve the Minutes for the City Council Regular Meetings of August 1-2, 2018. Councilmember Shaw seconded the motion. The motion prevailed by the following vote:

City Clerk Vacek administered the Oath of Office to Councilmember Viagran who will serve as Mayor Pro Tem from August 21, 2018 through October 30, 2018.

POINT OF PERSONAL PRIVILEGE

Mayor Nirenberg stated that next week would be the one-year anniversary of Hurricane Harvey's devastating landfall near Rockport, Texas. He recognized Mayor Pat Rios, his wife Patty, and City Manager Kevin Carruth of Rockport. Mayor Rios addressed the City Council and thanked them and the San Antonio Community for their support in the wake of the storm. Mayors Nirenberg and Rios thanked the many organizations that provided assistance to include: City of San Antonio, SAWS, CPS Energy, SA Foodbank, H-E-B Grocery, and AT&T. The City Council thanked Mayor Rios and City Manager Carruth for taking the time to come to San Antonio and wished them well in their continued recovery efforts. A Representative from the SA Area Foundation presented a check in the amount of \$98,000 to Mayor Rios for the Aransas County United Way to assist with much need support services in the Rockport Area.

INDIVIDUAL ITEMS FOR STAFF BRIEFING

City Clerk Vacek read the caption for Item 5:

5. Presentation by Dr. Steve Nivin of the anticipated fiscal impact to the City related to the City Charter Amendments proposed by the Fire Union. [Ben Gorzell, Chief Financial Officer; Troy Elliott, Deputy Chief Financial Officer]

Dr. Steve Niven presented economic and fiscal impacts of the City of San Antonio Charter Amendments proposed by the Fire Union. He stated that the main impacts derived from the uncertainty the amendments create. He noted that policy uncertainty lowers economic growth and that impacts were persistent over time. He outlined the impacts measured: 1) Reductions in City Revenues due to slower economic growth; 2) Crowding-out of non-public safety services; 3) Increased interest costs on debt due to lower bond rating; 4) Cost to administer elections; and 5) Wage Compression. He provided an overview of each impact and the methodology utilized. He reported cumulative impacts of \$382.3 million to \$4.2 billion over 20 years plus the crowding out of non-public safety expenditures in the range of \$408.3 million to \$693.3 million by 2038.

No action was required for Item 5.

City Clerk Vacek read the caption for Item 6:

6. Ordinance ordering an election for three City Charter Amendments proposed by the Fire Union to be held on Tuesday, November 6, 2018, in the City of San Antonio, Bexar County, Texas. [Andrew Segovia, City Attorney]

Andy Segovia stated that on April 11, 2018; the City Clerk received three petitions from the Fire Union for a Charter Amendment Election on the following: 1) Relax Referendum requirements and expand scope; 2) Limit compensation, term, and hiring of future City Manager; and 3) Allow Fire Union to unilaterally call for binding arbitration on Collective Bargaining Agreement negotiations. He reported that the City Clerk certified the signatures on May 17, 2018 and that State Law requires the City Council to call an election to be held on the next uniform election date (November 6, 2018). He spoke of Proposition A which would: 1) Expand the types of Ordinances that may be subject to referendum; 2) Increase the number of days a petition may be filed seeking a referendum on a Council Ordinance from 40 to 180 days after passage of the Ordinance and 3) Provide that no more than 20,000 signatures of reigsered voters are required for a referndum petition instead of 10% of electors qualified to vote at the last regular election. He noted that Proposition B would: 1) Limit the term a City Manager may serve to no more than 8 years; 2) Limit the compensation of the City Manager to no more than 10 times the annual salary furnished to the lowest paid full-time city employee; and 3) Require a supermajority vote to appoint the City Manager. He stated that Proposition C would provide the International Association of Fire Fighters Local 624 with unilateral authority to require the city to participate in binding arbitration of all issues in dispute. He added that next steps would include notice of the election to be published in the newspaper on the same day in each of two successive weeks and that the Contract for Election Services would be brought forth at a later date.

Mayor Nirenberg announced that this was a ministerial act being performed by the City Council and comments should be limited to placing the three amendments on the ballot. He called upon the citizens registered to speak.

Bob Martin, President of the Homeowner Taxpayer Association, spoke in support of the three Charter Amendments.

Nikki Kuhns played a video of a Northeast Neighborhood Alliance Meeting held on July 16, 2018 and expressed concern that Dr. Steve Niven was hired by the Political Action Committee opposing the Charter Amendments.

Maria Giresi stated that she was supportive of placing the Charter Amendments on the ballot.

Stanley Mitchell spoke in favor of placing the Charter Amendments on the ballot but expressed concern with the presentation by Dr. Steve Niven.

Jack M. Finger stated that the Charter Amendments were brought forth by the residents who wanted the opportunity to govern for themselves.

Phil Sevilla stated that the Firefighters Association had done an excellent job in giving the citizens of San Antonio a voice.

Betty Eckert stated that she was in favor of placing the three Charter Amendments on the ballot.

George Alejos expressed support for placing the three Charter Amendments on the ballot and asked the City Council to do the right thing.

Councilmember Treviño moved to adopt the Ordinance for Item 6. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

7. Ordinance amending the City Code, Chapter 15, Health, by adopting the initiated ordinance for earned paid sick time, or if the City Council does not adopt the initiated ordinance, then submitting the initiated ordinance to the electors on Tuesday, November 6, 2018, in the City of San Antonio, Bexar County, Texas. [Andrew Segovia, City Attorney]

Andy Segovia stated that on May 24, 2018; the City Clerk received an initiative on an Earned Paid Sick Time Ordinance. He noted that the City Clerk certified the signatures on August 2, 2018 and that a Reading and Public Hearing of the Ordinance was held on August 8, 2018. He outlined the terms of the Ordinance that requires employers within the City of San Antonio to provide earned paid sick time and applies to all employers except governmental entities. He stated that the Ordinance would be enforced by the Director of Metro Health and that a penalty of up to \$500 per violation may be imposed. Lastly, he noted that the City Council could adopt the Ordinance as written with an effective date of January 1, 2019 or reject the Ordinance and place it on the next regular election ballot (November 6, 2018).

Mayor Nirenberg called upon the citizens registered to speak.

John Agather, San Antonio Hispanic Chamber of Commerce, spoke in opposition to the Paid Sick Time Ordinance noting that it would cause an undue burden for small businesses. Ramiro Cavazos also spoke in opposition to the Paid Sick Time Ordinance noting that their over 1,200 members had voted unanimously in opposition.

Don Dixon stated that he was opposed to the Paid Sick Time Ordinance noting that mandated sick leave was not under the purview of the City Council.

Jack M. Finger spoke in opposition to the Paid Sick Time Ordinance noting that the issue should be mandated by businesses.

Michelle Tremillo, Joleen Garcia, and Mabel Diaz representing Working Texans for Paid Sick Time spoke in support of the Paid Sick Time Ordinance. They stated that all working people should be able to take care of themselves or a family member when they get sick.

Angie Garcia expressed support for the Paid Sick Time Ordinance.

Jose Camargo stated that he was supportive of the Paid Sick Time Ordinance noting that it

was difficult for him to take time off to care for his sick wife and daughters.

Luis Solis spoke in support of the Paid Sick Time Ordinance stating that it was a human right to receive paid time off to care for one's health or a family member.

Mia Ibarra stated that she was in support of the Paid Sick Time Ordinance.

Diana Uriegas expressed support for the Paid Sick Time Ordinance noting that her daughter had passed away after getting an illness from a co-worker.

Jesus Garcia stated that he was supportive of the Paid Sick Time Ordinance.

Councilmember Saldaña thanked everyone that worked on the Ordinance and recognized those that gathered petition signatures. He asked of the health implications if the Paid Sick Time Ordinance was adopted. Dr. Colleen Bridger replied that it would help stop the spread of disease. Councilmember Saldaña stated that the City of San Antonio had grown economically due to the workers in the service and tourism industries and that they would greatly benefit from a Paid Sick Time Ordinance.

Councilmember Saldaña moved to adopt the Ordinance for Item 7. Councilmember Treviño seconded the motion.

Councilmember Gonzales spoke of the importance of a strong workforce and expressed support for the Paid Sick Time Ordinance. Councilmember Treviño stated that he appreciated the process and also expressed support for the Paid Sick Time Ordinance.

Councilmember Perry stated that he empathized with the individuals that were in need of paid sick time; however, he expressed concern that there was a great amount of uncertainty regarding the impact of the Ordinance. He noted that a fiscal analysis was not conducted and that the amount of individuals impacted had not been validated. He asked how many petition signatures had been received and how many were verified. City Clerk Vacek replied that 142,885 signatures were received with 70,419 verified. Councilmember Perry asked of the legal issues. Mr. Segovia replied that the City Council had received a letter from the Attorney General noting that they cannot pass Ordinances that are pre-empted by State or Federal Law. Councilmember Perry expressed concern with a potential lawsuit and read a letter from State Representative Lyle Larson requesting that the City Council refrain from passing a Paid Sick Time Ordinance or placing the issue on the ballot. Councilmember Perry stated that he needed additional data on the impacts of the Paid Sick Time Ordinance.

Councilmember Perry moved to continue Item 7 until September 20, 2018. Councilmember Brockhouse seconded the motion. The motion to continue Item 7 failed by the following vote:

- **AYE:** 2 Brockhouse, and Perry
- NAY: 8 Mayor Nirenberg, Treviño, Shaw, Viagran, Saldaña, Gonzales, Sandoval, and Courage
- **ABSTAIN:** 1 Pelaez

Councilmember Pelaez confirmed that there were only two options for the City Council to consider. He spoke of his work as an Attorney for many years and noted that it was his professional opinion that the Paid Sick Time Ordinance was pre-empted by State Law. He stated that the issue should be addressed by the State Legislature as the Ordinance was well-intentioned but flawed. He added that he looked forward to working with stakeholders over the next 6 months to understand and analyze the costs associated with the Ordinance.

Councilmember Brockhouse stated that he concurred with Councilmember Perry regarding the need for additional information regarding the impacts of a Paid Sick Time Ordinance. He spoke of the challenges of small business owners throughout the city and added that he felt the issue should be placed on the ballot.

Councilmember Sandoval commended the individuals that gathered over 100,000 signatures and noted the many individuals that would benefit from a Paid Sick Time Ordinance. She spoke of her parent's and friend's personal experiences regarding paid sick time and noted that she would support the Ordinance for the people that greatly needed it. Councilmember Shaw stated that he was a small business owner and supportive of the Paid Sick Time Ordinance. However, he noted that he was not supportive of the language and looked forward to working with stakeholders on the implementation.

Councilmember Viagran confirmed that information regarding the associated costs was not available. She asked of the impact of the Ordinance on businesses that already had sick leave policies. Mr. Segovia replied that it would not affect those businesses that provided equal or above what was provided in the Paid Sick Time Ordinance. Councilmember Viagran recommended that a Task Force review the Ordinance and that a majority of its representation consist of women.

Mayor Nirenberg stated that he was in support of the Paid Sick Time Ordinance noting that no one should have to choose between keeping their jobs, paying their bills, or caring for themselves or sick family members. He noted that there was time for the Legislature to act on the issue as the Ordinance would not require compliance for one year. He added that he looked forward to working with all stakeholders and thanked everyone that participated in the process.

The motion to adopt the Ordinance for Item 7 prevailed by the following vote:

19. Ordinance naming Dr. Chichi Junda Woo, Medical Director for the San Antonio Metropolitan Health District, as Local Health Authority for San Antonio and surrounding areas of Bexar County. [Erik Walsh, Deputy City Manager; Colleen M. Bridger, MPH, PhD, Director of Health]

Dr. Colleen Bridger presented an overview of the duties of the Local Health Authority to include enforcing ordinances, sanitation laws, and quarantine rules; reporting contagious, infectious, and dangerous epidemic diseases; and implementing control measures during public health emergencies. She stated that staff recommended that the City Council

authorize the execution of a Certificate of Appointment of Local Heath Authority, naming Dr. Junda Woo, Metro Health's Medical Director, as the Local Health Authority for the City of San Antonio and surrounding areas of Bexar County.

Councilmember Sandoval asked of Dr. Woo's current role with Metro Health. Dr. Bridger responded that she was the Medical Director and a full-time employee. Councilmember Viagran thanked Dr. Woo for her work and service to the City of San Antonio.

City Clerk Vacek announced that five written testimonies were received in opposition to Item 19 from the following individuals: Patrick Von Dohlen, Michael Knuffke, Paula Moore, Terelyn Santos, and Dr. Catherine Nix.

Councilmember Sandoval moved to adopt the Ordinance for Item 19. Councilmember Viagran seconded the motion. The motion prevailed by the following vote:

Patty Zaiontz, Vice-President of the San Antonio Conservation Society, read a letter of support for Historic Landmark Designation from Susan Beavin, President of the San Antonio Conservation Society.

Councilmember Shaw called Patrick Christensen, Representative for the Property Owner, to the podium. Mr. Christensen stated that the property owner was opposed to the Historic Designation but there were three shotgun shack structures on the property that would be moved to 705 E. Grayson Street.

Councilmember Shaw moved to deny Historic Landmark Designation. Councilmember Viagran seconded the motion. The motion to deny prevailed by the following vote:

26. City Manager's Report

2018 SERVICES MANAGER OF THE YEAR

Mrs. Sculley reported that for the last eight years, Visit San Antonio has awarded the Services Manager of the Year during National Celebrate Services Week, created by the Event Services Professional Association. She stated that Visit San Antonio has used this week to recognize the contribution of Service Professionals, give back to the community, and award an individual as the Services Manager of the Year. She reported that on July 30th, the 2018 Services Manager of the Year was awarded to Delia Garcia, Event Manager at the Henry B. Gonzalez Convention Center. She noted that Ms. Garcia received 10 nominations from the clients she has served. She stated that Ms. Garcia has worked for the Convention Center for 21 years and served some of the city's largest conventions. She congratulated Ms. Garcia on the award and thanked her for her service to the City of San Antonio.

WINGS ACADEMY

Mrs. Sculley reported that last week, the Aviation Department hosted its 7th Class of the Wings Academy for children from the Roy Maas Youth Alternatives Campus. She stated that the week-long program exposes children ages 7-17 to Aviation Career Opportunities. She noted that students met with Airport Teams including the Airport Rescue, and toured the Airfield. In addition, the children received a tour of the Federal Aviation Administration's Air Traffic Control Tower as well as a behind the scenes tour with the Transportation Security Administration. She thanked other Airport Partners to include the Texas Air Museum at Stinson Airport, Dee Howard Foundation, and Witte Museum. Lastly, she reported that 77 children have attended the Wings Academy since 2013.

SUMMER READING PROGRAM

Mrs. Sculley reported that during the Summer, City of San Antonio Employees were invited to participate in a 10-week Reading Program hosted by San Antonio Youth Literacy. She stated that the program was conducted from June 4th through August 10th and included local 3rd, 4th, and 5th Grade Students aimed at maintaining reading skills over the Summer break. She noted that 31 City of San Antonio Employees volunteered for the Reading Program from 16 City Departments for a total of 147.5 volunteer hours.

STUFF THE BUS

Lastly, Mrs. Sculley reported on the Communities in Schools' Annual Stuff the Bus Event that has taken place for the past 20 years to collect supplies for schools throughout the community. She stated that supplies are made available to over 90 schools from 11 School Districts. She noted that the Stuff the Bus Event was held on August 4th at more than 32 participating HEB locations. She mentioned that this year, City Departments were challenged to stuff a VIA Bus and made it a friendly competition within the organization to see which department could collect the most supplies based on average weight collected per number of employees. She reported that a new City of San Antonio record was set with 2,795 pounds of school supplies collected with another 1,000 pounds collected on Event Day. She stated that the VIA Bus was stuffed and that the Government and Public Affairs Department won the friendly competition, averaging 12 pounds per person collected. She thanked everyone for their participation and generosity.

Councilmember Viagran stated that the United States Mint had revealed the official designs for next year's America the Beautiful Quarters Program and the San Antonio World Heritage Missions made the list.

Mayor Nirenberg recessed the meeting at 12:47 pm and announced that the meeting would resume at 2:00 pm for Zoning.

Melissa Ramirez presented Item Z-16 and stated that staff recommended approval while the

Zoning Commission recommended denial. She reported that of eight notices mailed; two were returned in favor and none in opposition. She noted that the applicant was amending their request to add "NA" and agreed to the following conditions: 1) No outdoor speakers or outdoor live music; 2) Building height and outdoor storage height shall not exceed 20 feet in height; 3) 20-foot landscape buffer is required on rear and front property line; and 4) Plantings must be from UDC Appendix E (native species) only. She added that the Friends of Friedrich Park Neighborhood Association was not opposed if conditions were placed.

Mayor Nirenberg called upon the citizens registered to speak.

Gerard Taylor spoke in opposition to the request and asked that they get the opinion of the Friends of San Antonio Nature Areas (FOSANA).

Jesse Taylor stated that he was the property owner and supportive of the request. He noted that he had owned the property for 31 years but the taxes had significantly increased and he could no longer afford to maintain the two-bedroom home as a rental.

David Wingo stated that he was opposed to the request due to the wilderness area that would be affected and safety issues.

Kayla Byrd spoke in opposition to the request noting that she grew up in the area and did not want to lose the parkland.

Brandon Byrd also spoke in opposition to the request noting that the property meant a great deal to his uncle.

Jerry Arredondo, Applicant, spoke in support of the request. He stated that they had met with the School District and several neighbors and they were not opposed to the rezoning. He showed a map of the area and noted that many of the surrounding properties were already zoned as Industrial. He added that they agreed to deed restrictions and the conditions read by Mrs. Ramirez.

Vicki Cade Arredondo stated that she was supportive of the request.

Linda Klekar stated that she was speaking on behalf of the Commercial Masonry Business trying to purchase the property in support of the request. She noted that they provided masonry services for HEB Grocery and many schools being built in San Antonio.

Faith Taylor spoke in opposition to the request noting that she had grown up visiting her grandparents that lived in the area.

JR Troy stated that he was a Real Estate Broker and supportive of the request that was in the best interest of the property owner.

Trey Huchingson spoke in opposition to the request noting that it would change the landscape of the area.

Julie Huchingson stated that she grew up in the area and was concerned with the traffic and debris that the commercial facility would bring to the neighborhood.

Councilmember Pelaez stated that they had been working with the Applicant, City Staff, and the Zoning Board. He noted that the case had been postponed several times in order to bring all parties together and gain consensus. He referenced a letter he received from Chris Porter representing FOSANA noting that the Board had voted not to oppose the rezoning provided that restrictions were placed in the covenants.

Councilmember Pelaez moved to approve Item Z-16 as amended and with the conditions read by Mrs. Ramirez. Councilmember Shaw seconded the motion. The motion to approve with conditions prevailed by the following vote:

Melissa Ramirez presented Item Z-21 and stated that staff recommended approval while the Zoning Commission recommended denial. She reported that of 15 notices mailed; none were returned in favor and seven in opposition. She noted that a petition was received from property owners outside the 200-foot radius with 45 in favor and 319 in opposition.

Mayor Nirenberg called upon the citizens registered to speak.

Brandon Melland stated that he was speaking on behalf of the applicant who was out of town and requested a continuance. He noted that there was confusion regarding the request and he would like the opportunity to clarify.

Angela Souder spoke in opposition to the request noting that there was already an oversaturation of alcohol sales in the area. She expressed concern with safety issues and noted that the zoning request had previously been denied in 2009.

Ann Quigley stated that she lived within 200 feet of the business requesting the zoning change and was opposed. She noted concerns for the safety of school children and added that she had received over 300 signatures from nearby residents opposed to the request.

Sandy Aguilar stated that she was the President of the Tejeda Middle School Parent Teacher Association (PTA) and the PTA voted to oppose the rezoning. She expressed concern with the close proximity to schools and homes and with increased traffic.

Councilmember Courage asked of the type of establishments allowed within a C-2 Designation. Mrs. Ramirez replied that liquor stores, restaurants with on premise consumption, car washes, and other retail uses were permitted within a C-2 Designation. Councilmember Courage stated that due to the great amount of opposition received from residents and the Tejeda Middle School PTA; he could not support the request.

Councilmember Courage moved to deny Item Z-21. Councilmember Saldaña seconded the motion. The motion to deny prevailed by the following vote:
