**AN ORDINANCE**

**AUTHORIZING THE EXECUTION OF AN INTERGOVERNMENTAL  
SUPPORT AGREEMENT (“IGSA”) BETWEEN THE CITY OF SAN  
ANTONIO AND JOINT BASE SAN ANTONIO (“JBSA”) TO ESTABLISH  
TERMS AND CONDITIONS FOR THE CITY TO PROVIDE THE  
MANAGEMENT AND CONSTRUCTION OF PAVEMENT PROJECTS  
ON MILITARY INSTALLATIONS OVER A FIVE-YEAR PERIOD; AND  
TO AUTHORIZE THE CITY TO ACCEPT FEDERAL FUNDS FROM  
JBSA FOR SAID PROJECTS.**

**WHEREAS**, in 2013, the Department of Defense received new authority to partner with state and local government entities to seek efficiencies and cost savings in the provision and acquisition of common services on military installations; and

**WHEREAS**, the United States Air Force has extensively utilized this new authority and currently has eight (8) intergovernmental support agreements in place with local governments nationwide saving the federal government millions of dollars and generating new revenue for local governments; and

**WHEREAS**, Joint Base San Antonio desires to enter into such an agreement with the City of San Antonio for the management and construction of pavement projects on JBSA installations; and

**WHEREAS**, according to review and analysis, the City of San Antonio acquires typical pavement mill and overlay services for approximately \$10 per square yard less than current JBSA acquisitions which would providing a cost savings to JBSA; and

**WHEREAS**, the City will provide the pavement and road work through its own contracting procedures which comply with state law and the extent of pavement and road work will include mill and overlays (including base and pavement repairs as needed), roadway stripping, tack coat and traffic control plans; and

**WHEREAS**, providing this service to JBSA under the IGSA will alleviate the backlog of pavement projects on JBSA and demonstrate community support to the bases; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Council approves the terms and conditions of An Intergovernmental Support Agreement between the City and Joint Base San Antonio. The Director of the City’s

Transportation and Capital Improvements Department is authorized to execute the Agreement, a copy of which, in substantial final form, is set out in **Exhibit A**. A copy of the fully executed agreement will be substituted for **Exhibit A** upon receipt of all signatures.

**SECTION 2.** This Ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage.
