AN ORDINANCE 2018-08-30-0661

APPROVING A CONSTRUCTION CONTRACT TO JERDON ENTERPRISES, LLC IN THE AMOUNT OF \$371,371.00 FOR THE MONUMENT AND DIRECTIONAL SIGNAGE PROJECT AT THE STINSON MUNICIPAL AIRPORT.

WHEREAS the 2013 Stinson Municipal Master Plan recommended completion of the monument and directional signage project at Stinson Municipal Airport which will create a well-defined airport entrance and provide identification and visibility for Stinson; and

WHEREAS, the City received two responsive bids in response to an invitation for bid released in May, 2018; and

WHEREAS, this Ordinance accepts the lowest responsive bid and approves a construction contract for the monument and directional signage project at Stinson in the amount of \$371,371.00 to Jerdon Enterprises, LLC; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid by Jerdon Enterprises, LLC, in the amount of \$371,371.00 for the monument and directional signage project at Stinson Municipal Airport is accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date of this Ordinance, whichever comes first.

SECTION 2. The budget in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00236, Stinson - Monument & Directional Signage, shall be revised by increasing the SAP WBS Elements as follows:

SECTION 3. The budget in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00236, Stinson - Monument & Directional Signage, shall be revised by decreasing SAP WBS element 33-00236-90-11-01 entitled Transfer from AV-00006-01-02-82, SAP GL account 6101100, by the amount of \$255,121.25.

SECTION 4. The amount of \$255,121.25 is reverted in SAP Fund 51013000, Airport Capital Improvements Fund, SAP WBS AV-00006-01-02-82, SAP GL account 6102100 – Interfund Transfer out entitled Transfer to 33-00236-90-11-01. The amount of \$255,121.25 is authorized to be transferred from SAP Fund 51099000.

SECTION 5. Payment in the amount not to exceed \$371,371.00 in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00236, Stinson - Monument & Directional Signage, is authorized to be encumbered and made payable to Jerdon Enterprises, LLC (Jerdon), for construction services.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 7. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
