## ORDINANCE 2018-09-06-0680

AUTHORIZING THE NEGOTIATION AND EXECUTION OF A CONSTRUCTION CONTRACT WITH SPAWGLASS CIVIL CONSTRUCTION INC. IN AN AMOUNT NOT TO EXCEED \$18,265,000.00 FOR THE CONSTRUCTION OF A LAND BRIDGE OVER WURZBACH PARKWAY, A 2017 GENERAL OBLIGATION BOND FUNDED PROJECT; AND, AMENDING THE FY 2018-2023 CAPITAL IMPROVEMENTS PROGRAM WITH THE APPROPRIATION OF \$182,325.00 FROM THE TREE CANOPY PRESERVATION AND MITIGATION FUND FOR THE HARDBERGER PARK 2017 BOND PROJECT.

WHEREAS, the Phil Hardberger Park is a 311 acre City Park that first opened in May 2010, and is divided by Wurzbach Parkway with the West Park located at 8400 N.W. Military and the East Park located at 13203 Blanco Road in Council Districts 8 and 9; and

WHEREAS, this project will construct the Phil Hardberger Park Land Bridge over Wurzbach Parkway connecting the West and East Parks in order to provide pedestrian, bicycle and wildlife mobility throughout the park; and

**WHEREAS**, in March 2018 the City released a Request for Competitive Sealed Proposal to construct the Phil Hardberger Park Land Bridge; and

WHEREAS, City received 6 proposals in April 2018, of which the evaluation committee, consisting of a representative from the City of San Antonio and the Phil Hardberger Park Conservancy, evaluated and ranked the submissions and recommends SpawGlass Civil Construction, Inc. be awarded the construction contract for this project; and

WHEREAS, it is necessary to authorize the negotiation and execution of a construction contract in an amount not to exceed \$18,265,000.00 with SpawGlass Civil Construction, Inc. to construct a land bridge over Wurzbach Parkway connecting the West and East Parks, a 2017 General Obligation Bond funded Project located in Council Districts 8 and 9; and

**WHEREAS**, the Tree Canopy Preservation and Mitigation Fund will pay for the installation and irrigation for establishment of some of the new trees in the project to increase the tree canopy on the project; and

**WHEREAS**, this Ordinance also amends the FY 2018-2023 Capital Improvements Program with the appropriation of \$182,325.00 from the Tree Canopy Preservation and Mitigation Fund for the Hardberger Park 2017 Bond Project; **NOW THEREFORE:** 

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

- **SECTION 1.** The City Manager, or her designee, is authorized to negotiate and execute a construction contract with SpawGlass Civil Construction Inc. in an amount not to exceed \$18,265,000.00 to construct a land bridge over Wurzbach Parkway connecting the West and East Parks.
- **SECTION 2.** The amount of \$183,325.00 is appropriated in SAP Fund 29619000, Tree Preservation, SAP Internal Order # 390000002XXX, SAP GL account 6102100 Interfund Transfer out entitled From 29619000 to 23-01666-90-14-01. The amount of \$183,325.00 is authorized to be transferred to SAP Fund 45099000.
- **SECTION 3.** The budget in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01666, Hardberger Park 2017, shall be revised by increasing SAP WBS Element 23-01666-90-14-01 entitled Transfer from I/O# 390000002XXX, SAP GL Account 6101100 Interfund Transfer In, by the amount \$183,325.00.
- **SECTION 4.** The amount up to \$183,325.00 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01666, Hardberger Park 2017, SAP WBS Element 23-01666-05-02-02, entitled Construction-Tree Canopy, SAP GL Account 5201140.
- SECTION 5. A Payment in an amount not to exceed \$11,265,000.00 in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01584, Hardberger Park, is authorized to be encumbered and made payable to SpawGlass Civil Construction Inc., to construct a land bridge over Wurzbach Parkway connecting the West and East Parks. Payments for services are contingent upon the availability of funds and the sale of future City of San Antonio, General Obligation Bonds in accordance with the adopted capital budget. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.
- **SECTION 6.** A Payment in an amount not to exceed \$5,000,000.00 in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01666, Hardberger Park 2017, is authorized to be encumbered and made payable to SpawGlass Civil Construction Inc., to construct a land bridge over Wurzbach Parkway connecting the West and East Parks. Payments for services are contingent upon the availability of funds and the sale of future City of San Antonio, General Obligation Bonds in accordance with the adopted capital budget. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.
- **SECTION 7.** A Payment in an amount not to exceed \$2,000,000.00 in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01451, Hardberger Park Phase V, is authorized to be encumbered and made payable to SpawGlass Civil Construction Inc., to construct a land bridge over Wurzbach Parkway connecting the West and East Parks.
- **SECTION 8.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the

City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 9.** This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


