CALL TO ORDER

Mayor Nirenberg called the meeting to order.

1. Consideration of Applicants for Alternates on the Zoning Board of Adjustment (6 Slots) [Leticia M. Vacek, City Clerk]

City Clerk Leticia Vacek presented background information for the Consideration of Applicants for Alternates on the Zoning Board of Adjustment (ZBOA). She reported that there are six alternate slots available and are appointed by Council for a two-year term.
