

AN ORDINANCE 2018-09-13-0727

**RESCHEDULING CITY COUNCIL MEETINGS IN NOVEMBER AND

WHEREAS, due to the City's Winter Break schedule, during which City offices are closed, and the National League of Cities Conference, the City Council of the City of San Antonio recommends rescheduling the City Council meetings of November 7-8, 2018 to November 14-15, 2018, and the December 19-20, 2018, and January 2-3, 2019 meetings to January 9-10, 2019; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:
