

## Project Background

- Fire Training Academy is located in CD 6
- Main Building A and B constructed in 2003
- Services include: providing official training programs firefighters
- Project included in the FY 2018 Deferred Maintenance Program
- Energy Savings Assessment completed May
   2018 to identify energy savings that are a direct result of replacement of HVAC system





## Project Scope

- Replace the following:
  - HVAC control system
  - Light switches to light occupancy sensors
  - Air-cooled chiller with a high efficiency air-cooled chiller
  - Reconfigure three existing air handling units to a single zone Variable Air Volume (VAV) system







## Benefits/Energy Savings

- Improve:
  - Ventilation
  - Temperature controls
  - Building energy efficiency
  - Overall system efficiency
- Allow schedules to be programmed
- Provide remote access to adjust temperatures
- Anticipate energy savings
