AN ORDINANCE

**AUTHORIZING THE EXECUTION OF AN AGREEMENT WITH
THE TEXAS DEPARTMENT OF TRANSPORTATION FOR THE
TEMPORARY STREET CLOSURE OF STATE RIGHT-OF-WAYS ON
OLD PEARSALL ROAD FROM MEDINA BASE ROAD TO
HILLBURN DRIVE IN CONNECTION WITH THE SURCLOVIA
EVENT HOSTED BY CITY COUNCIL DISTRICT 4 TO BE HELD ON
OCTOBER 27, 2018.**

WHEREAS, On October 27, 2018, City Council District 4 will host their 2nd annual SurClovía event where participants will be able to move freely on Old Pearsall Road from Medina Base Road to Hillburn Drive as depicted in **Exhibit A** and **Exhibit B** free of vehicular traffic from 10:00 AM to 2:00 PM; and

WHEREAS, Old Pearsall Road is a state-owned roadway, requested authorization from the Texas Department of Transportation ("TXDOT") for the temporary closure of Old Pearsall Road from Medina Base Road to Hillburn Drive is required; and

WHEREAS, TXDOT's policy for authorization for temporary closures of state-maintained roadways are formally granted by agreement, which must be executed between governmental jurisdictions that will be impacted by the temporary road closures; and

WHEREAS, the Transportation and Capital Improvements staff is working with sponsors developing the Traffic Control Plans, which will be utilized during the temporary street closure; and

WHEREAS, the City Council action will ensure that the temporary street closure from 9:00 AM to 3:00 PM on Saturday, October 27, 2018 will be permitted for this event. **NOW THEREFORE,**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute a Temporary Closure Agreement with the Texas Department of Transportation to allow for the temporary street closure of Old Pearsall Road from Medina Base Road to Hillburn Drive for the city's SurClovía event which will be held on October 27, 2018.

SECTION 2. There is no financial impact with this ordinance.

SECTION 3. This ordinance becomes effective 10 days after passage, unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it becomes effective immediately.

SURCLOVIA ON OLD PEARSALL ROAD, OCTOBER 27, 2018 - TRAFFIC CONTROL PLAN

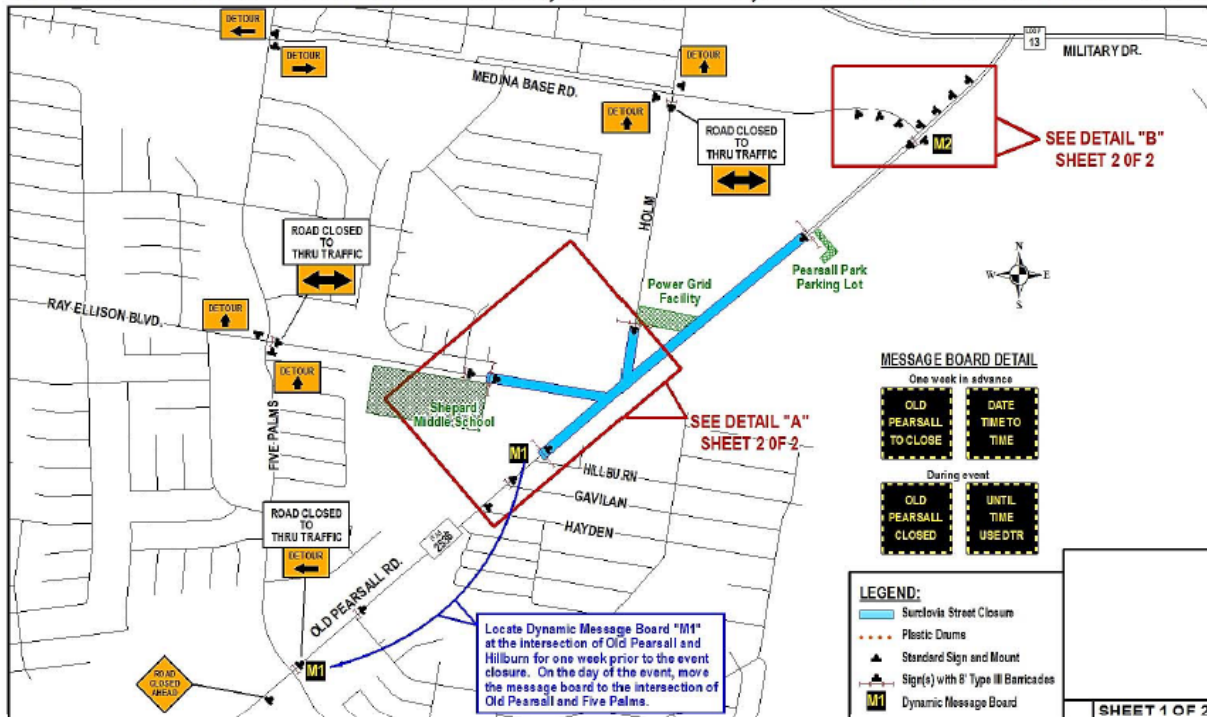
