

ORDINANCE 2018-10-04-0780

APPROVING AN AGREEMENT WITH THE TEXAS DEPARTMENT OF TRANSPORTATION (TXDOT) FOR THE TEMPORARY STREET CLOSURE OF STATE RIGHT-OF-WAY ON OLD PEARSALL ROAD FROM HILLBURN DRIVE TO MEDINA BASE ROAD FOR DISTRICT 4'S SURCLOVÍA EVENT TO BE HELD ON SUNDAY, OCTOBER 27, 2018.

WHEREAS, since 2011 siclovia events have been hosted in San Antonio on city streets in an effort to get people out and moving, and City Council District 4 will host *Surclopedia*, the second annual Southside event, on October 27th; and

WHEREAS, participants will also be able to partake in activities held within Pearsall Park as part of the event which include bike riding, Zumba, yoga, salsa dancing, wellness screenings, family games and face painting; and

WHEREAS, Old Pearsall Road is a state-owned roadway, requested authorization from the Texas Department of Transportation (TXDOT) for the temporary closure of Old Pearsall Road from Medina Base Road to Hillburn Drive is required; and

WHEREAS, TXDOT's policy for authorization of temporary closures of state-maintained roadways are formally granted by agreement, which must be executed between governmental jurisdictions that will be impacted by the temporary road closures; and

WHEREAS, the Transportation and Capital Improvements staff is working with the sponsors developing the Traffic Control Plans, which will be utilized during the temporary street closure; and

WHEREAS, this City Council action will ensure that the temporary street closure from 9:00 a.m. to 3:00 p.m. on October 27, 2018 will be permitted for this event; **NOW THEREFORE**,


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute a Temporary Closure Agreement with the Texas Department of Transportation to allow the temporary street closure of Old Pearsall Road from Hillburn Drive to Medina Base Road for the city's Surclopedia event which will be held on October 27, 2018.


SECTION 2. There is no financial impact with this Ordinance.
