## RENEWAL AND EXTENSION OF CONTRACT FOR COLLECTION OF DELINQUENT TAXES

This Renewal And Extension Of Contract For Collection of Delinquent Taxes ("Extension") is entered into by and between the CITY OF SAN ANTONIO, TEXAS (hereinafter referred to as "CITY"), a Texas Home-Rule Municipal Corporation, acting by and through its City Manager, or its Deputy Chief Financial Officer, pursuant to Ordinance No. 2018-11-01-\_\_\_\_, passed and approved November \_\_\_\_, 2018, and LINEBARGER GOGGAN BLAIR & SAMPSON, LLP, Attorneys at Law, (hereinafter referred to as "CONTRACTOR"), and is as follows:

**WHEREAS**, pursuant to Ordinance No. 2013-12-05-0863, passed and approved on December 5, 2013, CITY's City Council authorized the execution of a *Contract For Collection Of Delinquent Taxes* ("Contract") with CONTRACTOR to provide delinquent tax collection services for an initial five (5) year term commencing January 1, 2014, with the option in CITY to renew for one (1) additional five (5) year term under the same terms and conditions, subject to approval of CITY's City Council; and

WHEREAS, the initial five (5) year term of the Contract expires on December 31, 2018; and

**WHEREAS**, CITY desires, and CONTRACTOR has agreed, to renew and extend the Contract for the five (5) year extension, the term of which will commence January 1, 2019, and terminate December 31, 2023, under the same terms and conditions; **NOW, THEREFORE** 

**FOR VALUABLE CONSIDERATION**, CITY and CONTRACTOR hereby severally and collectively agree as follows:

## I. RENEWAL AND EXTENSION OF CONTRACT

1.1 Pursuant to the provisions of Article V. TERM of the Contract, CITY and CONTRACTOR mutually agree to renew and extend the term of the Contract for a period of five (5) years, commencing January 1, 2019, and terminating December 31, 2023, under the same terms and conditions as stated in the Contract.
