The City Council convened in a Regular Meeting. City Clerk Leticia Vacek took the Roll Call noting the following Councilmembers present:

City Clerk Vacek announced that Councilmember Shaw was attending the Pension Real Estate Association's Annual Institutional Investor Conference.

1. The Invocation was delivered by President Terry Orgill, San Antonio Temple Church of Jesus Christ of Latter-day Saints, guest of Councilmember John Courage, District 9.

2. Mayor Nirenberg led the Pledge of Allegiance to the Flag of the United States of America.

ITEMS PULLED FOR INDIVIDUAL CONSIDERATION

City Clerk Vacek read the caption for Item 16:

 Resolution in support of legislation awarding the Congressional Gold Medal to the Chinese American Veterans of World War II. [Carlos J. Contreras, Assistant City Manager; Jeff Coyle, Government & Public Affairs; Juan Ayala, Office of Military & Veteran Affairs]

General Juan Ayala spoke of the service of Chinese Americans in World War II and introduced Kin Hui, President of the Chinese American Citizens Alliance. Mr. Hui stated that he was in support of the Resolution to award the Congressional Gold Medal to Chinese American Veterans of World War II. He mentioned that at the start of World War II, there were 100,000 Chinese Americans living in the United States and many of them served under institutional discrimination because of their heritage. He stated that they deserved to be recognized for their service and sacrifice and thanked the City Council for their support.

Mayor Nirenberg called upon the citizens registered to speak.

Lila Woo addressed the City Council in support of the Resolution. She spoke of her father's service in the military and stated that he and other Chinese American Veterans should be recognized.

Esther Wong stated that her husband and children had served in the military and she was supportive of the Resolution.

Councilmember Brockhouse thanked city staff that worked on the Resolution. He stated that Chinese Americans had served the United States in every war since the Civil War and distinguished themselves in World War II in every branch of the armed forces. He noted that he hoped that Congress would take action and that he was pleased to move the Resolution forward.

Councilmember Viagran expressed her support and stated that she was pleased to learn of the impact that Chinese Americans played in World War II. Councilmember Perry stated that he was fully supportive of the Resolution.

Councilmember Courage also expressed his support and stated that it was never too late to recognize the contributions that Chinese Americans had made. Councilmember Saldaña commended all that worked on the Resolution and expressed his support. Mayor Nirenberg stated that he was pleased to support the Resolution and noted the recognition deserved by Chinese American Veterans.

Councilmember Brockhouse moved to approve the Resolution. Councilmember Viagran seconded the motion. The motion to approve prevailed by the following vote:

21. CITY MANAGER'S REPORT

POTHOLE REPAIR PROGRAM

Mrs. Sculley highlighted the Pothole Repair Program managed by the Transportation and Capital Improvements (TCI) Department. She noted that the program had gone through many changes over the last three years that have led to improvements in customer service, increased productivity, and a record number of potholes filled in FY 2018. She stated that the program consists of 16 crews divided equally among each quadrant of the city that proactively identify potholes and complete repairs within two business days. She indicated that to further optimize the repair process and improve customer service; the Pothole Patrol was established in 2018 as part of a new public campaign to engage the community and increase awareness of the pothole program. She stated that compared to previous years; TCI's proactive approach had produced notable results with 84,500 potholes repaired in FY 2018. She congratulated TCI and their Pothole Repair Crews for their great efforts.

FY 2019 ADOPTED BUDGET

Mrs. Sculley reported that the City's FY 2019 Budget of \$2.8 billion was posted on the City's Website on Monday, October 1st. She stated that the 777-page document detailing the City's Operating and Capital Spending Plan could be found on the City of San Antonio Budget Office Webpage. She noted that hard copies of the budget document would be available at City Libraries and the Office of the City Clerk next week. She mentioned that a Budget and Financial Transparency Website was created in 2014 as a way to provide the public a single point for access to its financial data. As part of this effort, the city implemented Opengov in 2017, a cloud-based financial tool that provides residents the ability to quickly and easily see the city's budget at the line item level and provides five years of historical information. She indicated that the FY 2019 Budget was available at the line item level in Opengov. She stated that quarterly updates would be provided to the public and City Council on the financial performance of the FY 2019 Budget, Initiatives, and Performance Metrics through the city's website and Opengov.

WORLD RABIES DAY

Mrs. Sculley reported that September 28th was World Rabies Day, a global health observance that started in 2007 to raise awareness of rabies and bring together partners to enhance prevention and control efforts worldwide. She stated that in San Antonio, the Animal Care Services Department partnered with the San Antonio Humane Society to provide free rabies vaccinations and microchips to pets of San Antonio Residents at the Brooks Spay/Neuter Clinic. She noted that during the event; 171 animals were provided free rabies vaccinations and 126 animals received free registered microchips.

Mayor Nirenberg recognized City Clerk Leticia Vacek who would be celebrating her birthday on Sunday, October 7th. The City Council sang Happy Birthday to City Clerk Vacek.

She noted that the applicant had agreed to added conditions: 1) No outside amplification systems; 2) No Loitering & No Trespassing signage must be visible and displayed on site at all times; and 3) Installation of a security camera on site. She reported that of 17 notices mailed; one was returned in favor and 9 in opposition. She stated that the Highland Hills Neighborhood Association was opposed to the request. She added that the case would require 9 votes to approve due to opposition exceeding 20%.

Mayor Nirenberg called upon the citizens registered to speak.

Raquel Borrego stated that she was opposed to the request noting that a car wash would not comply with the neighborhood plan. She mentioned safety concerns with a car wash and asked that the case be postponed in order to give the community the opportunity to speak with the property owner.

Santos Villarreal stated that he was speaking on behalf of the applicant in support of their request. He noted that they had met with the school and daycare in the area and had come to an agreement. He expressed concern that the community did not want any development in the area.

Ian Cochran stated that he was also speaking on behalf of the applicant in support of their request. He noted that they had worked with the neighborhood association and Jubilee Academy and had agreed to install a fence around the car wash.

Billie Zimmerman stated that she was opposed to the request noting safety concerns that a car wash would bring to the area.

Councilmember Viagran thanked all of the individuals that spoke and stated that she had heard many perspectives and concerns regarding the request. She noted that she also had concerns with the request due to the vacuums and 24-hour operation of the facility within a residential area. She expressed concern with the verbiage from the developer to neighborhood representatives and asked the applicant representatives if they would be amenable to a 30-day continuance. Mr. Ian Cochran replied that they were not agreeable to a continuance.

Councilmember Viagran moved to deny Item Z-10. Councilmember Treviño seconded the motion.
