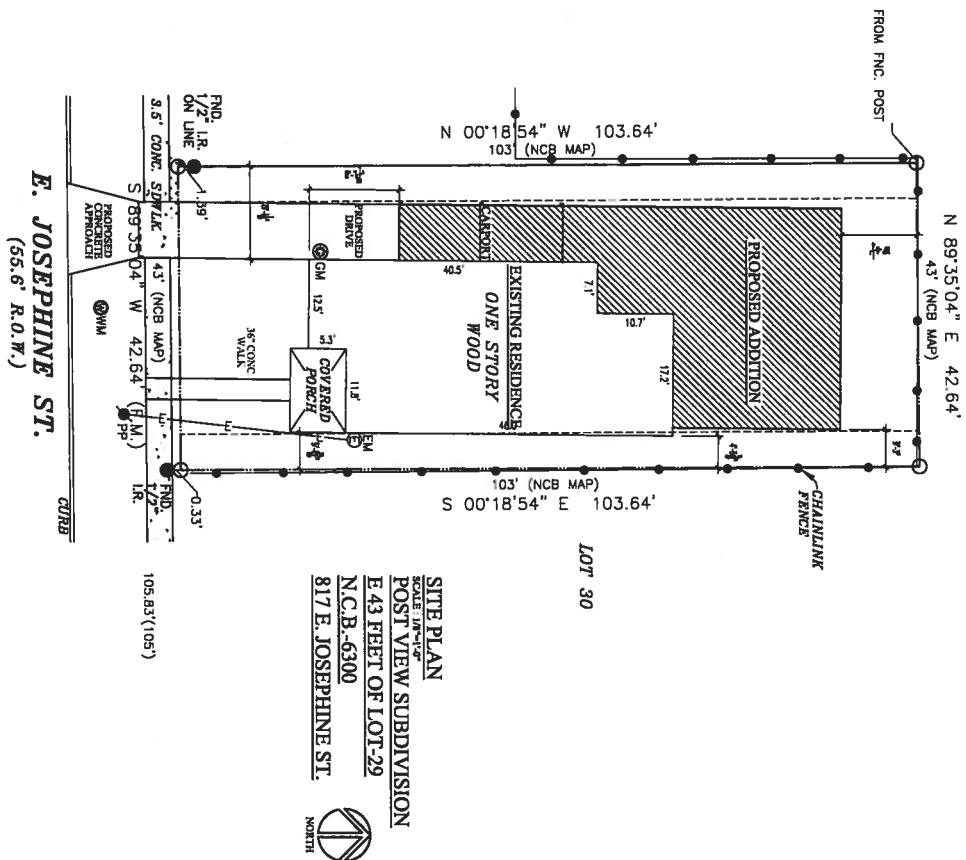

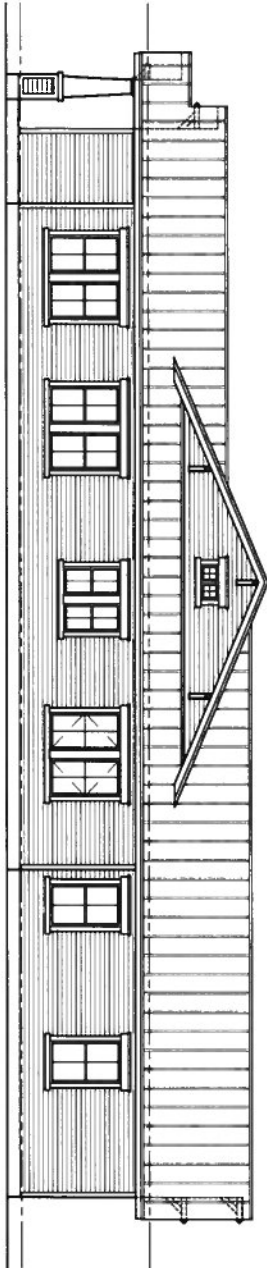

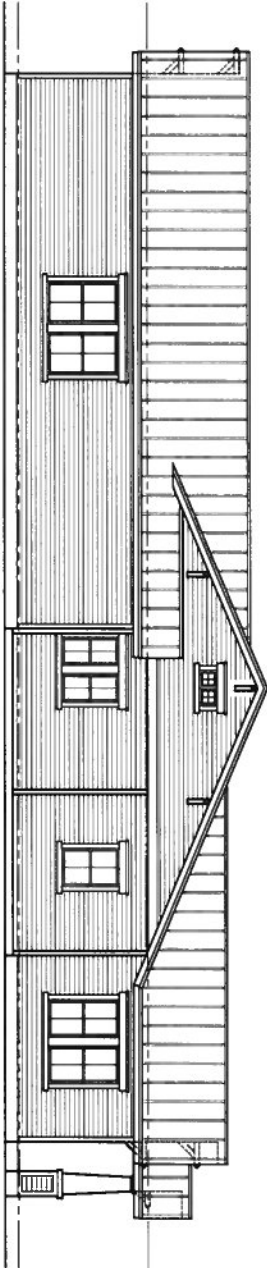
REAR ELEVATION
