### ORDINANCE 2018-11-15-0916

#### AUTHORIZING THE EXTENSION OF LINE-OF-DUTY INJURY LEAVE FOR SAN ANTONIO FIRE DEPARTMENT FIRE ENGINEER SHODY HENSHAW.

**WHEREAS**, section 143.073 of the Texas Local Government Code provides that a firefighter injured in the line of duty is entitled to line-of-duty injury leave with full pay for a period to commensurate with the injury and not to exceed one year; and

**WHEREAS**, section 143.073 also provides that a municipality's governing body may extend the line-of-duty injury leave beyond one year; and

WHEREAS, San Antonio Fire Department Fire Engineer Shody Henshaw was injured in the line of duty on December 23, 2015, and, as a result, required leave in excess of one year to address said injury; and

**WHEREAS**, Fire Engineer Henshaw is requesting an extension of line-of-duty injury leave beyond one year for the period December 23, 2016, to January 22, 2017 and April 11, 2017 to January 11, 2018; and

WHEREAS, approving the requested extension will restore 1,700 hours of accrued leave to Fire Engineer Henshaw; NOW THEREFORE:

#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** An extension beyond one year of San Antonio Fire Department Fire Engineer Henshaw's line-of-duty injury leave for the period December 23, 2016 to January 22, 2017 and April 11, 2017 to January 11, 2018, is hereby approved.

**SECTION 2.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
