

AN ORDINANCE 2018-11-29-0943

**AUTHORIZING AN EXTENSION TO THE PROFESSIONAL SERVICES AGREEMENTS WITH AECOM TECHNICAL SERVICES, INC. AND REYNOLDS, SMITH & HILLS, INC. FOR ON-CALL GENERAL ENGINEERING CONSULTING SERVICES FOR THE SAN ANTONIO AIRPORT SYSTEM TO INCREASE THE CONTRACT TERM FOR UP TO AN ADDITIONAL SIX MONTHS. THIS ACTION WILL NOT INCREASE THE CONTRACT VALUE FOR EITHER AGREEMENT FROM THE APPROVED VALUE OF \$5,750,000.00.**

**WHEREAS** in December of 2013 the City entered into Professional Services Agreements for General Engineering Consulting Services for the San Antonio Airport System with AECOM Technical Services, Inc. and Reynolds, Smith & Hills, Inc.; and

**WHEREAS**, those Agreements will expire on December 5, 2018 and the City wishes to extend these for an additional six months through June 5, 2019; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The amendments to the Professional Services Agreements with AECOM Technical Services, Inc. and Reynolds, Smith & Hills, Inc. are approved. The City Manager or her designee is authorized to execute the amendments, copies of which are set out in **Exhibits 1 and 2**.

**SECTION 2.** A Task Order contract was previously awarded to AECOM Technical Services, Inc. (formally the URS Corporation). in the amount of \$5,750,000.00 for on-call general engineering consulting services on Ordinance 2013-12-05-0856. This Ordinance is extending the contract term of the professional services agreements for up to an additional six months, the current agreement expires on December 5, 2018; this action will not increase the contract value.

**SECTION 3.** A Task Order contract was previously awarded to Reynolds, Smith & Hills, Inc., in the amount of \$5,750,000.00 for on-call general engineering consulting services on Ordinance 2013-12-05-0856. This Ordinance is extending the contract term of the professional services agreements for up to an additional six months, the current agreement expires on December 5, 2018; this action will not increase the contract value.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

**WHEREAS**, the contract will expire on December 5, 2018 and the Parties wish to extend the contract for an additional six months through June 5, 2019; and

**NOW THEREFORE**, in consideration of the terms, covenants, agreements and demises herein contained, and in consideration of other good and valuable consideration, each to the other given, the sufficiency and receipt of which are hereby acknowledged, the Agreement entered into by and between the City and the Consultant is amended as follows:

- 1. Article V. Time and Period of Service** is hereby amended to extend the term for an additional six months, through June 5, 2019.

Except as amended hereby, all other provisions of the Agreement are hereby retained in their entirety and remain unchanged.
