AUTHORIZING AN AMENDMENT AND EXTENSION OF A PROFESSIONAL SERVICES CONTRACT WITH LABORATORY CORPORATION OF AMERICA HOLDINGS, DBA LABCORP, TO PROVIDE MEDICAL LABORATORY TESTING FOR THE SAN ANTONIO FIRE DEPARTMENT WELLNESS CENTER BEGINNING JANUARY 1, 2019 THROUGH APRIL 30, 2019 IN AN AMOUNT NOT TO EXCEED \$20,000.00.

WHEREAS, the City entered into a contract with LabCorp to provide medical laboratory testing services; and

WHEREAS, the parties wish to extend the contract on a month to month basis beginning January 1, 2019 through April 30, 2019; and

WHEREAS, the cost of the Contract is an estimated annual amount not to exceed \$20,000.00; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Professional Services Contract Extension with Laboratory Corporation of America Holdings, dba LabCorp, to provide medical laboratory testing for the uniformed employees of the San Antonio Fire Department, as part of the Wellness Program, for the period from January 1, 2019 through April 30, 2019, for an estimated annual cost not to exceed \$20,000.00 is hereby approved. A copy of the Extension is attached hereto and incorporated herein as **Exhibit A**. The terms of the Extension are hereby approved. The City Manager, or her designee, is hereby authorized to execute the Extension.

SECTION 2. Funding in the amount of \$20,000.00 is available in Fund 11001000, Cost Center 2015090001 and General Ledger 5201040 as part of the FY2019 Budget.

SECTION 3. Funds will be encumbered upon issuance of purchase orders, and payment is authorized to Laboratory Corporation of America Holdings (LabCorp) and should be encumbered with a purchase order. All expenditures will be in accordance with the Fiscal Year 2019 and subsequent budgets that fall within the term period of this contract approved by City Council.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the

City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage.
