

ORDINANCE 2018-11-29-0948

**AUTHORIZING A CONTRACT WITH TARGETSOLUTIONS TO PROVIDE A WEB BASED ONLINE TRAINING SYSTEM FOR THE SAN ANTONIO FIRE DEPARTMENT. FUNDING FOR THIS CONTRACT IS AVAILABLE THROUGH THE FY 2019 GENERAL FUND ADOPTED BUDGET.**

**WHEREAS**, the City issued a Request for Competitive Sealed Proposals to provide a web based online training system for the San Antonio Fire Department; and

**WHEREAS**, a formal committee evaluation was conducted; and

**WHEREAS**, City staff now recommends TargetSolutions be awarded the contract; and

**WHEREAS**, said agreement provides for an initial three year term, beginning October 11, 2018 through October 10, 2021 with two (2), one (1) year options to renew; and

**WHEREAS**, the total estimated cost of this contract for three year period is \$394,935.00; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee is hereby authorized to execute a Professional Services Contract with TargetSolutions for a period beginning October 11, 2018 to October 10, 2021, with the option for the City to extend the contract for two (2) one (1) year renewals.

**SECTION 2.** Funding in the amount of \$131,645.00 is available in Fund 11001000, Cost Center 2015090002 and General Ledger 5203080 as part of the FY2019 Budget.


**SECTION 3.** Payment not to exceed the budgeted amount is authorized to TargetSolutions, LLC and should be encumbered with a purchase order.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.




