ORDINANCE

APPROVING EXECUTION OF A DEVELOPMENT AGREEMENT WITH SAM MAVERICK SPIRITS, LLC FOR THE MAVERICK WHISKEY PROJECT LOCATED AT 115 BROADWAY STREET IN CITY COUNCIL DISTRICT 1 AND WITHIN THE HOUSTON STREET TAX INCREMENT REINVESTMENT ZONE ("TIRZ"), IN AN AMOUNT NOT TO EXCEED \$15,000.00. PROJECTS FUNDED THROUGH THE HOUSTON STREET TIRZ ARE PAID SOLELY FROM THE TAX INCREMENT GENERATED.

WHEREAS, the City of San Antonio ("City") and the Houston Street TIRZ Board of Directors ("Board") support programs which allow for economic development within its boundaries; and

WHEREAS, on March 18, 2018, Sam Maverick Spirits, LLC submitted a request for TIRZ funding for the Maverick Whiskey Project located at 115 Broadway Street in City Council District 1, and within the boundary of the Houston Street TIRZ; and

WHEREAS, the Maverick Whiskey Project will include the renovation of the historic building which stands on what was originally the corner of the Maverick family homestead, to house a three story distilled spirits manufacturing plant; and

WHEREAS, the building will offer a dramatic improvement to the area landscape, and will feature a tasting room, office space, conference rooms, and a large rental space catering to both corporate and private events; and

WHEREAS, the total development cost for the Maverick Whiskey Project is approximately \$3,000,000.00, which includes the costs for site work, pre-development costs, hard construction costs, contingency, and developer related expenses; and

WHEREAS, the \$15,000.00 in Houston Street TIRZ funds will be utilized for public improvements and eligible project costs necessary to complete the Maverick Whiskey Project; and

WHEREAS, in accordance with Section 311.010 (b) of the Texas Tax Code, the Board is authorized to enter into agreements to dedicate revenue from the tax increment fund to pay for eligible project costs that benefit the TIRZ; and

WHEREAS, on June 25, 2018, the Board authorized approval of the negotiation of this Development Agreement to provide reimbursement for eligible project costs in an amount not to exceed \$15,000.00; and

WHEREAS, on October 22, 2018, the Board authorized approval of the execution of this Development Agreement to provide reimbursement for eligible project costs in an amount not to exceed \$15,000.00 and approval of City Council is now required; **NOW**, **THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and condition of a Development Agreement with Sam Maverick Spirits are hereby approved. The City Manager or her designee, or the Director of Finance or his designee, is hereby authorized to enter and execute said agreement, under terms and conditions substantially in accordance with those set forth in **Attachment I** to this Ordinance.

SECTION 2. Projects funded through the Houston Street TIRZ boundary are paid solely from the tax increment generated and will not impact the City's General fund.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance shall be effective immediately upon passage by at least eight (8) votes and the 10th day after passage by fewer than eight (8) votes.
