**ORDINANCE**

**APPROVING AN AMENDMENT TO THE SOUTHWEST TEXAS  
REGIONAL ADVISORY COUNCIL (STRAC) INTERLOCAL  
AGREEMENT FOR CONTINUED ACCESS AND MAINTENANCE TO  
VARIOUS STRAC-HOSTED SOFTWARE APPLICATIONS FOR FIRE  
AND EMERGENCY MEDICAL RESPONSE DATA REPORTING FOR  
AN INITIAL ESTIMATED COST OF \$612,690.90 FOR FY 2019.**

**WHEREAS**, Chapter 773 of the Texas Health and Safety Code provides the authority pursuant to which the Southwest Texas Regional Advisory Council (STRAC) has been established; and

**WHEREAS**, on May 10, 2007, pursuant to ordinance 2007-05-10-0528, the City Council authorized an Interlocal Agreement with STRAC to work collaboratively to establish a trauma data reporting system; and

**WHEREAS**, the San Antonio Fire Department (SAFD) is the recognized emergency medical services agency for the City and is able to provide paramedics, who are certified and able to record emergency services provided in the course of performing such services; and

**WHEREAS**, the Interlocal Agreement provides the SAFD Emergency Medical Services Division with software access and maintenance of various software applications hosted at STRAC that provide clinical and fire incident response data reporting capability; and

**WHEREAS**, this ordinance authorizes a second amendment to the Interlocal Agreement (ILA), which extends the term and consolidates several existing ILAs, involving the patient care reporting system, fire reporting system, mobile satellite radio and JOC radio support, into a single ILA; and

**WHEREAS**, the initial estimated cost is \$612,690.90 for FY 2019 and increases to an estimated cost of \$661,299.96 for FY 2023, with future price increases not to exceed 3% annually; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee is hereby authorized to execute a second amendment to the Interlocal Agreement with STRAC. The amendment is attached hereto and incorporated herein for all purposes as **Exhibit I**.

**SECTION 4.** The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

**SECTION 5.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
