**ORDINANCE**

**APPROVING THE FOLLOWING CONTRACTS ESTABLISHING UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED ANNUAL COST OF \$546,000.00, INCLUDED AND AVAILABLE IN THE ANIMAL CARE SERVICES DEPARTMENT'S FY 2019 ADOPTED GENERAL FUND BUDGET: (A) B&R ESTES CORP. DBA LOCKE HILL FEED, PET & LAWN SUPPLY, C-SPECIALTIES, INC., AND MWI ANIMAL HEALTH FOR PET SUPPLIES; (B) MIDWEST VETERINARY SUPPLY, INC., MWI ANIMAL HEALTH, NAO GLOBAL HEALTH LLC, AND PATTERSON VET SUPPLY FOR VETERINARY SUPPLIES; AND (C) INTERVET INC. DBA MERCK ANIMAL HEALTH FOR FELINE AND CANINE BIOLOGICALS.**

**WHEREAS**, bids were submitted to provide the City of San Antonio with commodities and services on an annual basis for the terms of the contracts; and

**WHEREAS**, this Ordinance approves the following contracts: (A) B & R Estes Corp. dba Locke Hill Feed, Pet & Lawn Supply, C-Specialties, Inc., and MWI Animal Health for pet supplies; (B) Midwest Veterinary Supply, Inc., MWI Animal Health, NAO Global Health LLC, and Patterson Vet Supply for veterinary supplies; and (C) Intervet Inc. dba Merck Animal Health for feline and canine biologicals; and

**WHEREAS**, the Texas Local Government Code section 252.022(a)(2) indicates that competitive bidding is not required for a procurement necessary to protect the public health or safety; and

**WHEREAS**, this Ordinance approves seven low bid contracts and one contract procured on the basis of the health or safety exemption; and

**WHEREAS**, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE**:

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The following bids to furnish the City with goods and services on an annual basis as shown on the attached bid tabulation sheets are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements: (A) B & R Estes Corp. dba Locke Hill Feed, Pet & Lawn Supply, C-Specialties, Inc., and MWI Animal Health for pet supplies; (B) Midwest Veterinary Supply, Inc., MWI Animal Health, NAO Global Health LLC, and Patterson Vet Supply for veterinary supplies; and (C) Intervet Inc. dba Merck Animal Health for feline and canine biologicals. **SECTION 2.** Funds will be encumbered upon issuance of purchase orders and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2019 budget and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

**SECTION 3.** This Ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
