ORDINANCE

AUTHORIZING THE EXECUTION OF A FUNDING AGREEMENT BETWEEN THE CITY OF SAN ANTONIO AND THE ISLAMIC ACADEMY OF SAN ANTONIO AND ACCEPTING UP TO 50% OF THE COST, ESTIMATED AT \$7,800.00, FOR THE CONSTRUCTION AND INSTALLATION OF ADVANCED WARNING SCHOOL FLASHING BEACONS IN COUNCIL DISTRICT 8.

WHEREAS, the City has a School Flasher Matching Program funded through the FY 2019 School Pedestrian Safety Program whereby schools, interested in installing or enhancing existing flashing warning beacons, are eligible to receive a 50% match of actual cost from the City up to \$50,000.00; and

WHEREAS, the Islamic Academy of San Antonio is a nonprofit educational organization located at 8638 Fairhaven Street between Datapoint Drive and Medical Drive in Council District 8; and

WHEREAS, the Islamic Academy of San Antonio is interested in completing the installation of a set of flashing beacon assemblies to include two roadside mounted solar powered flashing beacons along Fairhaven Street and has requested the City's services to construct and install the necessary equipment for the flashing beacon; and

WHEREAS, the estimated total cost for construction and installation for the set of flashing beacons assemblies is \$15,600.00 and the Islamic Academy of San Antonio will fund 50% of the total amount, estimated at \$7,800.00, and the remaining 50% will be funded by the City; and

WHEREAS, this Ordinance authorizes the execution of an Advanced Funding Agreement between the City of San Antonio and the Islamic Academy of San Antonio and accepts up to 50% of the cost, or \$7,800.00, for the construction and installation of a set of advanced warning flashers; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is hereby authorized to execute a Funding Agreement with the Islamic Academy of San Antonio and accept payment for 50% of the cost, estimated at \$7,800.00, for the City's construction and installation of advanced warning school flashing beacons at the Islamic Academy of San Antonio located in Council District 8. A copy of the Agreement is substantially final form is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 2. Funds are authorized to be received from Islamic Academy of San Antonio to SAP fund 40099000, Other Capital Projects, SAP Project Definition 23-01817, FY 2019 School Pedestrian Safety, and the budget shall be revised by increasing WBS element 23-01817-90-10-01, Islamic Academy Contribution, SAP General Ledger 4502280, Contribution from other Agencies, by the amount of \$7,800.00.

SECTION 3. The amount of \$7,800.00 is appropriated in SAP Fund 40099000, Other Capital Projects, SAP Project Definition 23-01817, FY2019 School Pedestrian Safety, SAP WBS Element 23-01817-05-02-10, Islamic Academy and SAP General Ledger 5201245.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective on the en days after passage.
