A RESOLUTION

SUBMISSION AUTHORIZING THE OF **GRANT** Α APPLICATION TO AND AUTHORIZING THE ACCEPTANCE OF FUNDS FROM THE OFFICE OF THE GOVERNOR FOR THE CRIMINAL JUSTICE PROGRAM IN AN AMOUNT NOT TO EXCEED \$69,075.00 BEGINNING OCTOBER 1, 2019 THROUGH SEPTEMBER 30, 2020 FOR **ANTONIO** METROPOLITAN THE SAN **HEALTH** DISTRICT'S STAND UP SA PROGRAM.

WHEREAS, according to the U. S. Census Bureau, San Antonio's population in 2014 was 1,436,697 making it the 7th largest city in the United States; and

WHEREAS, during 2014, San Antonio was ranked 7th, out of the top 10 most populated cities in the United States in the number of homicide deaths, with 7.17 deaths per 100,000 population; and

WHEREAS, the total number of homicides listed on the San Antonio Police Department's website for San Antonio in 2014 was 103; and

WHEREAS, in 2014 there were 33 murders in Stand Up SA's target area, comprised of four neighborhoods; and

WHEREAS, the population of the four neighborhoods was 83,520; and

WHEREAS, this equates to one-third of all the murders in the City of San Antonio being committed within the boundaries of these four neighborhoods; and

WHEREAS, these neighborhoods contain only six percent of the population of San Antonio; and

WHEREAS, the goals of the San Antonio Metropolitan Health District's (Metro Health) Stand Up SA program includes establishing meaningful, collaborative, and sustainable partnerships within targeted neighborhoods and educating the public regarding methodology to reduce gun violence; and

WHEREAS, with funding from the Governor's Office, Metro Health will hire a temporary full-time case manager and purchase a laptop computer/software; and

WHEREAS, Metro Health requests City Council authorize the department's submission of a grant application to and authorize the acceptance of funds awarded from the Office of the Governor for the Criminal Justice Program; **NOW THEREFORE:**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee or the Director of the San Antonio Metropolitan Health District or her designee is authorized to submit a grant application to and accept funds from the Office of the Governor for the Criminal Justice Program in an amount not to exceed \$69,075.00 beginning October 1, 2019 through September 30, 2020 for the San Antonio Metropolitan Health District's Stand Up SA Program. A copy of said grant application which is incorporated herein for all purposes is on file with the San Antonio Metropolitan Health District.

SECTION 2. [FINANCIAL LANGUAGE PENDING]

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Resolution is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
