WHEREAS, the City of San Antonio ("City") is a current Lead Hazard Reduction Demonstration ("LHRD") grantee from the United States Department of Housing and Urban Development's ("HUD") Office of Healthy Homes and Lead Hazard Control; and

WHEREAS, the Michigan Technological University ("MTU") has been awarded a Lead Technical Studies grant from HUD to complete Phase III of their research project to test a removal method for lead-based paint contaminated soils; and

WHEREAS, the City's Green and Healthy Homes Program participated in the first two phases of MTU's research and has been selected to participate in MTU's third phase of its research project; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The submission of a grant application and, upon award, the acceptance of grant funds in an amount up to \$29,000.00 from Michigan Technological University for reimbursement of allowable costs for "A Novel Phytoremediation Method to Cleanup Lead-Based Paint Contaminated Soils: Phase III-Demonstration Study" for the period March 1, 2018 through February 28, 2021, and the execution of a research agreement for the City of San Antonio to participate in said study, are hereby ratified and approved. The City Manager or her designee, or the Director of Neighborhood & Housing Services or her designee, is hereby authorized to take all such actions necessary, if any, to ratify the submission of the grant application and the execution of the research agreement, and to accept said grant funds.

SECTION 2. The City Manager or her designee, or the Director of Neighborhood & Housing Services or her designee, is further authorized to execute any and all necessary documents to effectuate said application, research agreement and acceptance.

SECTION 3. Upon acceptance of this award, new funds and internal order numbers will be created, upon which the award amount not to exceed \$29,000.00 will be appropriated in said funds. A final budget, including Internal Orders and GL Accounts, will be submitted by Neighborhood & Housing Services upon award.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost

Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance shall become effective immediately upon passage by eight (8) or more affirmative votes of the entire City Council; otherwise, said effective date shall be ten (10) days from the date of passage hereof.
