ORDINANCE 2019-02-21-0133

APPROVING A CONSTRUCTION CONTRACT WITH D. WILSON CONSTRUCTION COMPANY IN AN AMOUNT NOT TO EXCEED \$1,340,689.00 FOR THE EXPANSION OF THE TERMINAL A SECURITY CHECKPOINT AT SAN ANTONIO INTERNATIONAL AIRPORT, AN AIRPORT INTERIM FINANCING FUNDED PROJECT.

WHEREAS, an increase in the number of travelers flying out of San Antonio International Airport has increased the number of passengers to be processed by Transportation Security Administration (TSA) during peak travel times, straining the checkpoint capacity in Terminal A resulting in extended wait times for customers; and

WHEREAS, this contract will add a new lane increasing TSA processing capacity and allowing faster processing of passengers; and

WHEREAS, in October 2018 the City released a Request for Competitive Sealed Proposals for a Terminal A security checkpoint expansion at San Antonio International Airport with responses due in November 2018; and

WHEREAS, an evaluation committee, comprised of representatives from the Aviation Department, Transportation & Capital Improvements and Aviation Advisory Commission, evaluated and scored two submissions and recommends awarding a construction contract to D. Wilson Construction Company for the expansion of the Terminal A Security Checkpoint; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager, or her designee, is authorized to execute a construction contract with D. Wilson Construction Company for the expansion of the Terminal A Security Checkpoint at San Antonio International Airport in an amount not to exceed \$1,340,689.00.

SECTION 2. Payment in the amount of \$1,340,689.00 in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00221, Terminal A Security Checkpoint Expansion, is authorized to be encumbered and made payable to D. Wilson Construction Company, for construction services.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
