APPROVING AMENDMENT NO. 2 TO THE LICENSE AGREEMENT WITH SAN ANTONIO ELITE YOUTH SOCCER ACADEMY FOR OPERATIONS AND MAINTENANCE OF THE DESIGNATED SPORTS FIELDS AT 1600 E. BITTERS RD FOR AN ADDITIONAL FIVE YEAR PERIOD ENDING ON DECEMBER 31, 2023.

WHEREAS, San Antonio Elite, a Youth Soccer Academy has an established community presence since 2014. The league utilized the designated sports fields at 1600 E. Bitters Rd to provide organized youth sports activities year round; the league serves over 1,000 youth per week; and

**WHEREAS**, on February 20, 2014, the league entered into Sports License Agreement for approximately 15 acres of Aviation Department land, located at 1600 E. Bitters Rd. which is leased to the Parks and Recreation Department, for a five (5) year term ending on February 28, 2019, with a renewal option of an additional term of five years; and

**WHEREAS**, on August 8, 2016, Amendment #1 approved additional 0.49 acres to allow for expansion of the League's parking space; and

**WHEREAS,** Amendment #2 shall commence upon Council approval and expire December 31, 2023; and

**WHEREAS**, in lieu of rent, the league shall be responsible for operations and maintenance of the designated sports fields at 1600 E. Bitters Rd; **NOW THEREFORE**:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or designee or the Director of the Department of Parks and Recreation or designee, is hereby authorized to execute an amendment No. 2 to the License Agreement with San Antonio Elite Youth Soccer Academy for operations and maintenance of the designated sports fields at 1600 E. Bitters Rd extending the term for an additional five year period ending on December 31, 2023. A copy of the License Agreement is attached hereto and incorporated herein for all purposes as **Attachment I.** 

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the

City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 3.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
