AMENDING THE LAND USE PLAN CONTAINED IN THE SAN ANTONIO INTERNATIONAL AIRPORT VICINITY PLAN, A COMPONENT OF THE COMPREHENSIVE MASTER PLAN OF THE CITY, BY CHANGING THE USE OF APPROXIMATELY 0.4829 ACRES OF LAND LOCATED AT 3951 EISENHAUER ROAD, LEGALLY DESCRIBED AS LOT 11, BLOCK 2, NCB 12524 FROM "HIGH DENSITY RESIDENTIAL" TO "COMMUNITY COMMERCIAL".

WHEREAS, the San Antonio International Airport Vicinity Plan was adopted on May 20, 2010 by City Council as a component of the City's Comprehensive Master Plan adopted May 29, 1997; and

WHEREAS, the Unified Development Code requires consistency between zoning and the Comprehensive Master Plan and Section 213.003 of the TEXAS LOCAL GOVERNMENT CODE allows amendment of the Comprehensive Master Plan following a public hearing and review by the Planning Commission; and

WHEREAS, a public hearing was held on February 13, 2019 by the Planning Commission allowing all interested citizens to be heard; and

WHEREAS, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The San Antonio International Airport Vicinity Plan, a component of the Comprehensive Master Plan of the City, is hereby amended by changing the use of approximately 0.4829 acres of land located at 3951 Eisenhauer Road, legally described as Lot 11, Block 2, NCB 12524, from "High Density Residential" to "Community Commercial". All portions of land mentioned are depicted in **Attachment "T"** attached hereto and incorporated herein for all purposes.

SECTION 2. This ordinance shall take effect March 17, 2019.
