#### **ORDINANCE**

AUTHORIZING THREE PROFESSIONAL SERVICES AGREEMENTS FOR ON-CALL GENERAL ENGINEERING CONSULTING SERVICES FOR THE SAN ANTONIO AIRPORT SYSTEM WITH ATKINS NORTH AMERICA, INC., REYNOLDS, SMITH AND HILLS, INC. AND JACOBS ENGINEERING GROUP, INC. EACH IN THE AMOUNT NOT-TO-EXCEED \$5,000,000.00 FOR AN INITIAL TERM OF THREE YEARS WITH TWO, ONE-YEAR RENEWAL OPTIONS.

WHEREAS, these on-call general engineering consulting agreements will provide for comprehensive airport planning, engineering, architectural, and project/construction management consulting services for the San Antonio Airport System; and

WHEREAS, these services are needed to assist with the implementation and execution of the Capital Improvement Program (CIP) which includes federal grants, and Operation & Maintenance projects, while maintaining funding eligibility requirements; and

WHEREAS, the City released a Request for Qualifications in September, 2018 and received six proposals, and an evaluation committee composed of representatives from the Aviation Department, the Transportation and Capital Improvements Department, CPS Energy and the Airport Advisory Commission reviewed the proposals and selected Atkins North America, Reynolds, Smith and Hills, Inc. and Jacobs Engineering Group, Inc. as the most qualified respondents; and

WHEREAS, it is necessary to authorize the execution of three Professional Services Agreements, each with a three year term with a two one-year extension options, in an amount not to exceed \$5,000,000.00 with Atkins North America, Reynolds, Smith and Hills, Inc. and Jacobs Engineering Group, Inc. for this work; NOW THEREFORE,

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or designee is authorized to execute three Professional Services Agreements with Atkins North America, Reynolds, Smith and Hills, Inc. and Jacobs Engineering Group, Inc., each in an amount not to exceed \$5,000,000.00 for on-call general engineering consulting services for the San Antonio Airport System, copies of which are set out in **Exhibits 1,2 and 3**.

**SECTION 2.** Funding for this ordinance will be identified when work orders are issued. If funding for any work orders is not previously appropriated, funding will be identified and appropriated through subsequent City Council action. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with Operating and/or Capital Budgets and is included in the FY 2019 - 2023 Capital Improvements Program.

**SECTION 3.** Payment not to exceed \$5,000,000.00 within the term of the 3 year agreement, it is authorized to be encumbered with a purchase order and made payable to Atkins North America, Inc., for on-call comprehensive airport planning, engineering, architectural, and project/construction management consulting services.

**SECTION 4.** Payment not to exceed \$5,000,000.00 within the term of the 3 year agreement, it is authorized to be encumbered with a purchase order and made payable to Reynolds, Smith & Hills, Inc., for on-call comprehensive airport planning, engineering, architectural, and project/construction management consulting services.

**SECTION 5.** Payment not to exceed \$5,000,000.00 within the term of the 3 year agreement, it is authorized to be encumbered with a purchase order and made payable to Jacobs Engineering Group, Inc., for on-call comprehensive airport planning, engineering, architectural, and project/construction management consulting services.

**SECTION 6.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 7.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
