ORDINANCE

**AWARDING A CONSTRUCTION CONTRACT TO E-Z BEL
CONSTRUCTION, LLC IN AN AMOUNT NOT TO EXCEED \$491,260.00
FOR THE RANDOLPH WEIDNER INTERSECTION PROJECT, A
CERTIFICATE OF OBLIGATION AND GENERAL FUNDED PROJECT
IN COUNCIL DISTRICT 10.**

WHEREAS, the intersection of Randolph at Weidner Road has been the site of frequent crashes prompting a crash data review of the intersection by the Transportation & Capital Improvements (TCI) Department to determine improvements for driver safety; and

WHEREAS, City Council adopted the FY 2018 Consolidated Operating and Capital Budget on September 14, 2017, by Ordinance No. 2017-09-14-0652 which allocated \$500,000.00 for the Randolph Weidner Intersection Project; and

WHEREAS, this Ordinance awards a construction contract for widening of sidewalks and outside lanes, reconstruction of the signal at the intersection, re-striping of the intersection adding protected left turn lanes on Weidner Road, and upgrading the existing wire traffic signals to meet current standards; and

WHEREAS, the City advertised for construction bids in September 2018 and opened bids in October 2018 and one bidder responded; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by E-Z Bel Construction, LLC in an amount not to exceed \$491,260.00 for the Randolph Weidner Intersection Project; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid by E-Z Bel Construction, LLC in an amount not to exceed \$491,260.00 for the Randolph Weidner Intersection Project, is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates.
