SECTION 1. Jeffrey S. Beyer (HVAC Contractor - Open Shop -Primary) is re-appointed and Robert B. Jones (Master Plumber - Union - Primary), Jennifer Alley (Mechanical/Plumbing Engineer - Alternate), Scott E. Burger (HVAC Contractor - Open Shop - Alternate), Karen C. Carpenter (Fire Protection Engineer - Alternate), Michelle S. Davis (Commercial Building Contractor - Alternate), and George L. Saliba (Master Plumber- Open Shop - Alternate) are appointed to the Building-Related and Fire Codes Appeals and Advisory Board for terms of office to expire May 31, 2019.


