FIELD NOTE  
DESCRIPTION OF QUINTANA ROAD RIGHT-OF-WAY  
0.328 OF ONE ACRE (14,266 SQ. FT.) PARCEL OF LAND**

**BEING** 0.328 (14,266 sq. ft.) acres of land being out of Lester Ave. from Alley North of McKenna to intersection of Quintana Road, Re-subdivision of the North Part of Block 30, N.C.B. 8787, South San Antonio-Second Filing, as recorded in Volume 980, Page 424-425, South San Antonio Bexar County Texas second filing, as recorded in Volume 368, Page 183, San Antonio, Bexar County, Texas, which said 0.309 of one acre (13,458 square feet) parcel of land being more particularly described by metes & bounds as follows:

**BEGINNING** at a 1/2" rebar with a "CEC" plastic cap set, on the west right-of-way line of Quintana Road and the west right-of-way of Lester Avenue, the northeast corner of said Lot 5, for the northwest corner of this parcel;

**THENCE** North 65°14'02" East, departing said right-of-way line, along the north line of this parcel, across said Lester Ave., a distance of 37.61 feet to a point in the east right-of-way line of Lester Ave., for the northeast corner of this parcel;

**THENCE** South 05°52'10" West, along said right-of-way line of Lester Avenue, a distance of 488.01 feet to a point, for the southeast corner of this parcel;

**THENCE** North 07°45'16" West, across Lester Ave., a distance of 20.96 feet to a point, for an angle point of this parcel;

**THENCE** North 24°41'38" West, continuing across Lester Ave., a distance of 54.22 feet to a point, for the southwest corner of this parcel, said point being in the west right of way line of Lester Ave.;

**THENCE** North 05°53'26" East, departing said right-of-way line, along the west right of way line of Lester Ave., a distance of 401.78 feet to the **POINT OF BEGINNING** and containing 0.328 of one acre (14,266 square feet) of land, more or less.


