

ORDINANCE 2019-04-18-0328

**AUTHORIZING THE FIRST AMENDMENT TO THE AUDIO
VISUAL AND RIGGING SERVICES AGREEMENT AT THE
HENRY B. GONZALEZ CONVENTION CENTER WITH
AUDIOVISUAL SERVICES GROUP, INC. D/B/A PSAV
PRESENTATION SERVICES, EXTENDING THE AGREEMENT
THROUGH SEPTEMBER 30, 2019.**

WHEREAS, Ordinance No. 2011-04-21-0320 authorized the execution of an Agreement for Audio Visual and Rigging Services ("Agreement") with Audiovisual Services Group, Inc. d/b/a PSAV Presentation Services ("PSAV") to provide preferred audio visual services and exclusive rigging to event clients of the Convention Center, through April 30, 2016, with a three-year renewal option, and the City and PSAV exercised the three-year renewal by the passage of Ordinance No. 2016-04-14-0285, extending the Agreement through April 30, 2019; and

WHEREAS, the City issued a Request for Proposals for Audio Visual and Rigging Services on December 14, 2018 and conducted vendor interviews in the month of March 2019 and the proposed amendment would allow the City to complete the solicitation process, by extending the Agreement through September 30, 2019; and **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of the First Amendment to the Audi Visual and Rigging Services Agreement with PSAV are authorized and approved. The City Manager, or his designee, is authorized to execute the First Amendment, a copy of which has been executed by PSAV and is attached to this Ordinance as Exhibit I.


SECTION 2. Funds generated by this Ordinance will be deposited into Fund 29006000, Internal Order 2420000000001 and General Ledger Accounts 4407739 and 4407740.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


SECTION 4. This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.

**FIRST AMENDMENT TO THE AGREEMENT FOR AUDIO VISUAL AND RIGGING
SERVICES AT THE HENRY B. GONZALEZ CONVENTION CENTER**

This First Amendment ("First Amendment") to the Agreement for Audio Visual and Rigging Services at the Henry B. Gonzalez Convention Center is entered into by and between the City of San Antonio ("City") and Audiovisual Services Group, LLC (f/k/a Audiovisual Services Group, Inc.) d/b/a PSAV ("Contractor"), together referred to as the "Parties," as authorized and approved by Ordinance No. 2019-04-18-_____.

WHEREAS, City and Contractor entered into the Agreement for Audio Visual and Rigging Services at the Henry B. Gonzalez Convention Center pursuant to Ordinance No. 2011-04-21-0320, passed and approved on April 21, 2011; and

WHEREAS, the Agreement was extended for the available three-year renewal term until May 1, 2019; and

WHEREAS, the Parties wish to amend the Agreement to extend the Agreement to provide time to conduct a solicitation process for audio visual and rigging services;

NOW THEREFORE, in consideration of the mutual covenants and agreements contained in the Agreement, the receipt and adequacy of which are acknowledged, the Parties agree as follows:

1. Article II is amended to extend the Agreement through September 30, 2019.
2. No Other Changes. Except as specifically set forth in this First Amendment, all of the terms and conditions of the Agreement shall remain the same and are ratified and confirmed.
